RECOMMENDED MOTION:

That the Board of Supervisors:

1. Approve and authorize the Chairman of the Board to sign the attached Amendment #1 to Agreement #CS-01078 with Prevent Child Abuse Riverside County (PCARC) for the period of July 1, 2009 through June 30, 2010 for an amount not to exceed \$ 518,919;
2. Authorize the Director of the Department of Public Social Services (DPSS) to administer the agreement; and
3. Authorize the Purchasing Agent, in accordance with Ordinance No. 459, to exercise the renewal option, based on the availability of fiscal funding, and to sign amendments that do not change the substantive terms of the agreement, including amendments to the compensation provision that do not exceed the annual CPI rates.

SUBJECT: Approval of Amendment #1 for contract CS-01078 between DPSS and the Prevent Child Abuse Riverside County (PCARC)

BACKGROUND (Continued):

On March 17, 2009, the Honorable Board of Supervisors approved and designated, through Agenda number 3.54, Prevent Child Abuse Riverside County (PCARC) as the County children's Trust Fund Council in accordance with Welfare and Institutions Code Sections 18965 through 18970.

PCARC is the lead agency coordinating the regional child abuse councils and planning bodies and leads the community's efforts in the areas of child abuse prevention and intervention.

PCARC has requested an increase of \$79,499, to improve their current outreach and prevention programs. Since July 1, 2009, PCARC has performed 32 Mandated Reporter trainings with a total of 802 people trained and six additional abuse prevention trainings county-wide. PCARC has redesigned and expanded the community education and outreach activities to include a significant public awareness campaign and the addition of a seventh regional collaborative group in Blythe. PCARC has also participated in 14 health fair events, including educational conferences and the Indio Date Festival, with an exposure to over 13,600 people. Their presence includes sponsoring seven county-wide events with an attendance total exceeding 5,300, and public awareness campaigns through displays in malls (over 2,000,000 shoppers per month), donated bill board displays, radio talk shows appearances, and the Riverside Chamber of Commerce Mixer.

PCARC has expanded their staff in the last year to include a professional fund raiser with the hope of expanding prevention services and programs, and reducing the ongoing need for this level of funding to support these services.

At this time, PCARC is requesting the \$79,499 to be used to support the redesigned Public Awareness and Education Campaign, Prevention Resource Kits (delivered to schools within the County) and back packs for distribution to social workers for use with children who must be removed from their homes. This increase is one time funding.

FINANCIAL:

The funds for this increase are from the Children's Trust Fund with no fiscal impact to the County general budget.


