RECOMMENDED MOTION: That the Board of Directors:

1. Accept the La Canada Way Street Improvements Project constructed by Contreras Construction Company as complete and authorize the Clerk of the Board to file the Notice of Completion; and
2. Authorize the release of the \$17,045 in retained funds to the contractor in accordance with the contract terms.

BACKGROUND: On January 26, 2010, the Board of Directors approved the construction agreement between Contreras Construction Company and the Redevelopment Agency for the County of Riverside. The project has been inspected and found to comply with all contract requirements. This board action will release the balance of the contract retention funds of \$17,045 to Contreras Construction Company 35 days after the Notice of Completion is filed.
