**BACKGROUND:** The Department of Environmental Health is primarily supported by fees charged to a customer for a service that is provided. Upon occasion it is necessary to revise the ordinance to adjust or set the fee to properly cover the costs associated with the service or provide clarity to an existing fee. This particular ordinance revision would add fees associated with a new service due to change of responsibility, reinstitute some unintentional omissions, add State mandated fees, and provide clarity to existing fee descriptions. It is anticipated that another revision to Ordinance No. 640 may be submitted in Fall 2010 to include a modest fee increase, which will be brought back for approval and further described at that time.
