

WHEREAS, the hereinafter described portions of 15th Avenue, 16th Avenue, Quail Trail, Camino Zangri, Henderson Road, Gail Way and Corkill Road were offered for dedication for public road and public utility purposes by the maps and documents hereinafterreferred to, which offers of dedication have not been previously accepted for public use by the County of Riverside, now, therefore;

BE IT RESOLVED, DETERMINED AND ORDERED by the Board of Supervisors of the County of Riverside, State of California, in regular session assembled on June 8 2010, that this Board accepts the offers of dedication and recognizes that said roads are public roads open for use by the general public;

BE IT FURTHER RESOLVED, DETERMINED, AND ORDERED that this acceptance is for the purpose of vesting title in the County of Riverside on behalf of the public for public road and utility purposes, and is not an acceptance of the roads into the County Maintained Road System pursuant to Section 941 of the Streets and Highways Code and that said roads

will not become part of the County Maintained Road System unless subsequently accepted into said Maintained Road System by a resolution adopted by this Board;

Said roads are in the County of Riverside, State of California, and are described as follows:

15th Avenue, 16th Avenue, Quail Trail, Henderson Road and Gail Way (See Exhibit "A")

15th Avenue (60.00 feet wide), 16th Avenue (30.00 feet wide), Quail Trail (30.00 feet wide), Henderson Road (60.00 feet wide) and Gail Way (30.00 feet wide) as shown on Record of Survey, recorded in Book 22, Page 25 of Record of Surveys, records of Riverside County, California.

15th Avenue, Gail Way, Camino Zangri, and Corkill Road, (See Exhibit "A")

15th Avenue (30.00 feet wide), Gail Way (30.00 feet wide), Camino Zangri (60.00 feet wide), and Corkhill Road (30.00 feet wide) as shown on Record of Survey, recorded in Book 18, Page 67 of Record of Surveys, records of Riverside County, California.


