May 18, 2010 **SUBJECT:** Approve a revision of contract agreements with 8 contractors for FY 2009/2010 and

allow Purchasing Agent to enter into contract amendments.

RECOMMENDED MOTION: That the Board of Supervisors:

1) Approve the increase of funds in the amount of \$312,377 from the original amount of \$3,882,625 for a new total of \$4,460,926 and allow the Purchasing Agent to enter into contract amendments to increase or transfer funding amounts between service providers not to exceed 10% of the annual aggregate budget in order to meet service needs.

BACKGROUND: The enclosed agreements represent additional one time only funds that were given to the Office on Aging for our contractors for Riverside County for FY 2009/2010.

- 1. The Original Agreement in the amount of \$ 3,882,625.00 was Board approved on June, 23, 2009, Agenda number 3.36.
- 2. The agreements were increased on various dates during FY 09/10 by the purchasing agent authority for \$265,924 for a new revised amount of \$4,148,549.

SUBJECT: Approve a revision of contract agreements with 8 contractors for FY 2009/2010 and allow Purchasing Agent to enter into contract amendments.

BACKGROUND: (continued)

We are requesting revisions to the contractors' funds. These one time only funds were approved and appropriated to the Office on Aging's budget on May 4, 2010 agenda number 3.61. We are returning to the Board to increase our contractor's amounts by \$312,377 for a revised amount of \$4,460,926. Effective, January 14, 2010, through July 1, 2010, the one time only funds can be used to increase baseline services. Also, one time only funds can be used to purchase equipment, fund home and community based projects, or innovative pilot projects approved by the California Department of Aging (CDA).

These agreements continue a vital service to frail seniors in Riverside County. This service target seniors in Riverside County that need: Title III B Personal and Homemaker Services, Title III B Adult Day Care, Title III & VII Information and Assistance, Title III E Access Comprehensive Assessment, Title III E Access Programs (HICAP) Ombudsman Services; Title III C-1 Congregate Meals, Title III C-2 Home Delivered Meals; Title III E Family Caregiver Support Group, Title III E Family Caregiver Respite, Title III E Access.

Additionally, the Office on Aging would like the Board of Supervisors to allow the Purchasing Agent to expedite service provider contract budget increases or transfers of funds between Senior Service Providers not to exceed ten percent (10%) of the revised annual aggregate contractor totals.

Processing Contract Amendments through the Form 11 process utilizes a large amount of staff time (both Office on Aging and other County staff). Approval by the Board of Supervisors of this recommended motion would allow the Office on Aging to efficiently expedite contract budget adjustments to deliver much needed services to the community in a timely manner.

Attachment A1 of the Form 11 gives a breakdown of service provider, program and service descriptions, dollar amounts, and total contract amounts per service provider.

The Office of County Counsel has approved these agreements as to form.

Financial Impact: No county general fund cash match is required to receive these funds. The office on Aging will provide an In-kind contribution of 10 percent (\$31,237.70) to meet the match requirements.
