**SUBJECT: PURCHASE GARTNER SERVICES**

**BACKGROUND (Continued):**

Gartner provides Information Technology departments with industry technical experts that assist organizations make effective decisions and selections in a market where technology and communication providers continue to be volatile.

In the fall of 2003, the California County Information Services Directors Association (CCISDA) went out to RFP for industry research firms. This was done in an effort to get better volume pricing through a consolidating government purchasing vehicle. A three year contract was awarded to Gartner in May 2004 and is intended for City, County and other local entities. The County has taken advantage of this contract to realize lower pricing. The contract award has been renewed by CCISDA for the period May 1, 2008 through April 30, 2011 to renewal annually.

DPSS wishes to take advantage of the discounts offered by the CCISDA contract. As Gartner is the only provider of the CCISDA contract, there is no other alternative vendor.
