SUBJECT: PURCHASE OF FIFTEEN (15) PATROL VEHICLES FROM OTHER THAN THE LOW BID, IN ACCORDANCE WITH THE LOCAL PREFERENCE POLICY, FOR THE SHERIFF'S DEPARTMENT

RECOMMENDED MOTION: That the Board of Supervisors:

Approve the purchase of fifteen (15) patrol vehicles from other than the low bidder, in accordance with Ordinance No. 459.4 and the Local Preference Policy, at a cost of \$373,296, which is an additional cost of \$8,287.

BACKGROUND: In October 1995, the Board of Supervisors approved a local vendor preference program. Purchasing issued a formal Request for Quotation for Patrol Vehicles on behalf of the Sheriff's Department. A statement informing bidders of the local preference policy was included in the bid instructions. Bids were sent to five (5) vendors and three (3) bid responses were received ranging from \$365,009 to \$385,098. The overall low responsive and responsible bidder was Redlands Ford (Redlands, CA) for a total amount of \$365,009. The low responsive and responsible Riverside County firm, Raceway Ford, submitted a bid of \$373,296 for a difference of \$8,287. This differential is within the five percent approved by the Board. In addition, the fifteen (15) patrol vehicles were previously approved for purchase as per schedule 23 for Purchasing & Fleet's 2009/2010 budget.
