SUBJECT: Amendment to the Professional Medical Services Agreement between the County of Riverside and Renaissance Radiology Medical Group, Inc., aka Arlington Radiology Medical Group, Inc.

RECOMMENDED MOTION:

BACKGROUND: On December 6, 2005, Agenda Item No. 3.21, an agreement was approved with Renaissance Radiology Medical Group, Inc., aka Arlington Radiology Medical Group, Inc. to provide professional radiology services for the hospital. The Third Amendment extends the term of the Agreement and language was added for automatic renewal of the Agreement on an annual basis, unless otherwise terminated.

**THIRD AMENDMENT
TO THE
AGREEMENT
BETWEEN THE
COUNTY OF RIVERSIDE
AND
RENAISSANCE RADIOLOGY MEDICAL GROUP, INC.
aka ARLINGTON RADIOLOGY MEDICAL GROUP**

That certain Agreement, by and between the County of Riverside (COUNTY), a political subdivision of the State of California, on behalf of the Riverside County Regional Medical Center (HOSPITAL) and Renaissance Radiology Medical Group, Inc. aka Arlington Radiology Medical Group (CONTRACTOR) dated July 1, 2005, amended on November 1, 2007 and March 2009 is hereby amended effective July 1, 2010, as follows:

1. Delete Section 4.0 **TERM/TERMINATION** in its entirety and replace with the following:

"4.0 TERM/TERMINATION

4.1 This Agreement will be effective from July 1, 2005, through June 30, 2010 and automatically continue on a year-to-year basis thereafter. Either party may terminate this Agreement immediately for a breach of this Agreement, by giving written notice to the other parties. Failure to abide by the agreed terms and conditions may result in immediate termination of the Agreement."

2. Delete the last sentence in Section 5.0 in its entirety and all references to it.

All other terms and conditions of this Agreement are to remain in full force and effect.
