SUBJECT: Resolution No. 2010-095 - Authorizing Mt. San Jacinto Community College to Form One or More School Facilities Improvement Districts Under the Education Code

RECOMMENDED MOTION: That your Honorable Board approve and adopt Resolution No. 2010-095, to make provisions of the Education Code that authorize the formation of School Facilities Improvement Districts applicable to the Mt. San Jacinto Community College District.

BACKGROUND: Mt. San Jacinto Community College District (District) encompasses 1,700 square miles in central and southwestern Riverside County. The District Board of Trustees wants to form one or more School Facilities Improvement Districts (SFID) within its boundaries. The formation of an SFID provides a mechanism for the District to issue and sell voter-approved bonds secured by taxes levied on real property located within the boundaries of the SFID. The SFID provisions of the Education Code (Code) provide for the formation of an SFID, (which usually consists of a portion of the territory within the school district or community college district), the holding of a bond election within the boundaries of the SFID, and the issuance of general obligation bonds by the school or community college district on behalf of the SFID. The proceeds of the voter-approved bonds would then be available to finance capital improvements.

Pursuant to Section 15303 of the Code, the formation of an SFID can only take place if the County Board of Supervisors first adopts a resolution making the Code's SFID provisions applicable to the school or community college district. The District Board of Trustees has asked this Board to adopt Resolution No. 2010-095 to make the Code's SFID provisions applicable to the District so that the District can proceed with the formation of one or more SFIDs within the District's boundaries.

Resolution No. 2010-095 makes the Codes' SFID provisions applicable to the District and allows the District to proceed with the formation of one or more SFIDs. Although the adoption of Resolution No. 2010-095 would allow the District to form one or more SFIDs, the adoption of Resolution No. 2010-095 does not authorize the issuance or sale of any bonds. The District will not issue any bonds for any SFID without first obtaining voter-approval.

The Office of County Counsel has reviewed Resolution No. 2010-095 and has approved it as to form,

WHEREAS, California Education Code Section 15303 provides that the Law shall not be operative in any county until the board of supervisors of the county by resolution adopted by a majority vote makes said chapter applicable therein; and

WHEREAS, this Board of Supervisors of the County has determined that it is desirable and in the interests of the Community College District to permit the formation of the School Facilities Improvement District, upon appropriate action by the Board of Trustees of the Community College District pursuant to the Law;
