- Owner Ophelia M. Wallace and Roy G. Wallace, Trustees of the Ophelia M. Wallace and Roy G. Wallace Revocable Trust Dated December 24, 1998, or whoever has possession and control of the subject real property, be directed to abate the accumulation of rubbish on the property by removing and disposing of the same from the real property within ninety (90) days.
- (3) If the owner or whoever has possession or control of the real property does not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent of the owner or receipt of a Court Order authorizing entry onto the real property, when necessary under applicable law, shall abate the accumulation of rubbish by removing and disposing of the same from the real property.
- (4) The reasonable cost of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance Nos. 541 and 725.
- (5) County Counsel be directed to prepare the necessary Findings of Facts and Conclusions that the accumulation of rubbish on the real property is declared to be in violation of Riverside County Ordinance No. 541, and a public nuisance, and further, to prepare an Order to Abate for approval by the Board.

JUSTIFICATION:

- An initial inspection was made of the subject property by the Code Enforcement Officer on September 14, 2009.
- 2. The inspection revealed an accumulation of rubbish on the subject property in violation of Riverside County Ordinance No. 541. The items included but were not limited to: wood, green waste, six tires, trash and miscellaneous debris.
- 3. Subsequent follow up inspections of the above-described real property on December 2, 2009, January 16, 2010, and April 10, 2010 revealed that the property continued to be in violation of Riverside County Ordinance No. 541.
- 4. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for the removal of accumulated rubbish.

I, Regina Keyes, declare that the facts set forth below are personally known to me except to the extent that certain information is based on information and belief which I believe to be true, and if called as a witness, I could and would competently testify thereto under oath:

I am currently employed by the Riverside County Code Enforcement Department as a Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting property for violations and enforcement of the provisions of Riverside County Ordinances.

- On September 14, 2009, I conducted an initial inspection of the real property described as 2. 52043 Riza Avenue, Cabazon, Riverside County, California and further described as Assessor's Parcel Number 528-142-004 (hereinafter referred to as "THE PROPERTY"). A true and correct copy of a Thomas Brothers map indicating the location of THE PROPERTY is attached hereto as Exhibit "A" and incorporated herein by reference.
- A review of County records and documents disclosed that THE PROPERTY is owned by Ophelia M. Wallace and Roy G. Wallace, Trustees of the Ophelia M. Wallace and Roy G. Wallace Revocable Trust Dated December 24, 1998 (hereinafter referred to as the "OWNER"). A certified copy of the County Equalized Assessment Roll for the year 2009-2010 and a copy of the County Geographic Information System ("GIS") report are attached hereto as Exhibit "B" and incorporated herein by reference.
- Based on the Lot Book Report from RZ Title Service on September 24, 2009 it is determined that there are no additional parties that may potentially hold a legal interest in THE PROPERTY. A true and correct copy of the Lot Book Report is attached hereto as Exhibit "C" and

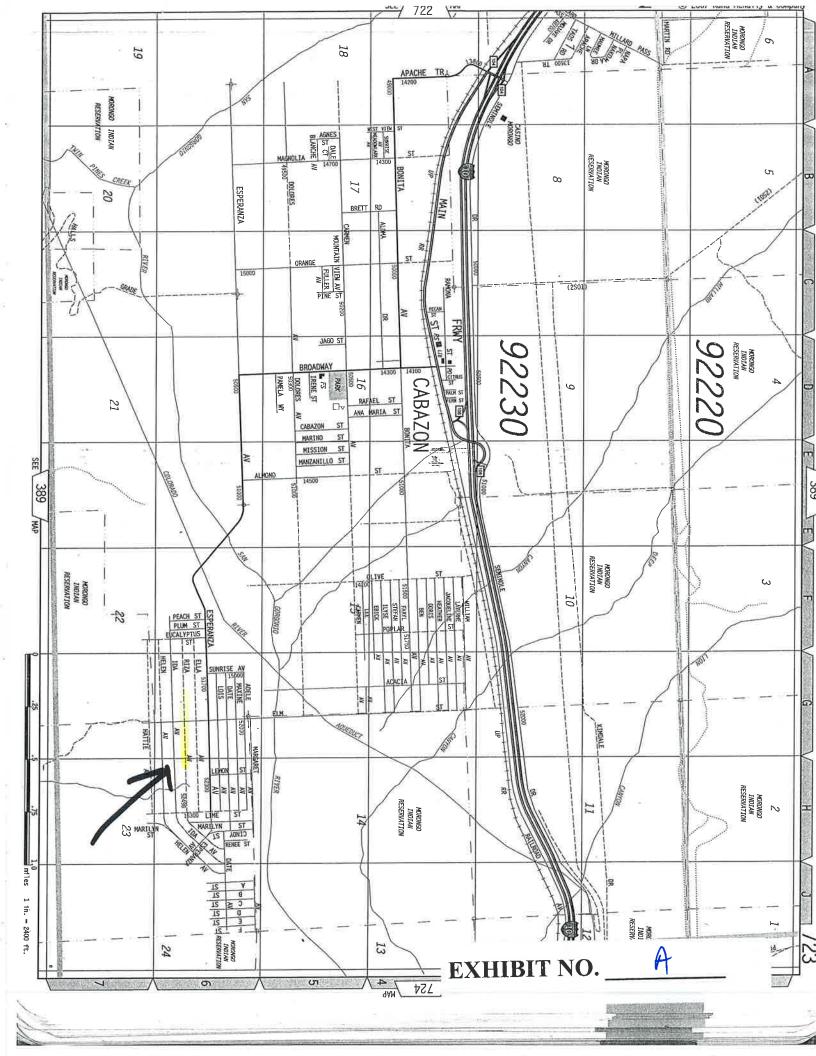

- 5. On September 14, 2009, I went to THE PROPERTY to conduct an inspection. I observed THE PROPERTY to be surrounded by a chain link fence that was locked with visible rubbish. From outside the fence of THE PROPERTY I observed accumulated rubbish on THE PROPERTY consisting of but not limited to: green waste, trash, and debris. Using the fence post method of measuring, I measured one hundred eighty (180) square feet of rubbish on THE PROPERTY. I posted a Notice of Violation on THE PROPERTY.
- 6. As a result of the accumulation of rubbish, THE PROPERTY constituted a public nuisance in violation of the provisions set forth in Riverside County Ordinance No. 541, as codified in Riverside County Code Title 8.120.
- 7. A site plan and photographs of THE PROPERTY are attached hereto and incorporated herein by reference as Exhibit "D."
- 8. True and correct copies of each Notice issued in this matter and other supporting documentation are attached hereto as Exhibit "E" and incorporated herein by reference.
- 9. On October 22, 2009, a Notice of Violation was mailed to the OWNER by certified mail with return receipt requested
- 10. A Notice of Noncompliance regarding the accumulation of rubbish was recorded in the Office of the Assessor, County Clerk & Recorder, County of Riverside, State of California, on October 6, 2009, as Instrument Number 2009-0518213 A true and correct copy of the notice is attached hereto and incorporated herein by reference as Exhibit "F".
- 11. On December 2, 2009, I conducted a follow-up inspection of THE PROPERTY. I observed the parcel remained in violation of Riverside County Ordinance No. 541.
- 12. On January 16, 2010, I conducted a follow-up inspection of THE PROPERTY. I observed the accumulated rubbish continued to remain on THE PROPERTY in violation of the provisions set forth in Riverside County Ordinance No. 541. I observed rubbish consisting of but not limited to wood, trash, debris, approximately six tires and other miscellaneous items.

Officer Declaration

- 13. Based upon my experience, knowledge and visual observations, it is my determination that the conditions on THE PROPERTY are dangerous to the neighboring property owners and the general public.
- 14. On April 10, 2010, I conducted a follow-up inspection of THE PROPERTY. I observed the parcel remained in violation of Riverside County Ordinance No. 541.
- 15. On April 8, 2010, the second notice "Notice to Correct County Ordinance Violations and Abate Public nuisance" providing notification of the Board of Supervisors' hearing scheduled for June 8, 2010, as required by Riverside County Ordinance No. 725, was mailed to THE OWNER by certified mail, return receipt requested and on April 10, 2010, was posted on THE PROPERTY. True and correct copies of the notice, returned receipt cards, together with the proof of service, and the affidavit of posting of notices are attached hereto as Exhibit "G" and incorporated herein by reference.
- 16. The removal of the accumulated rubbish currently on THE PROPERTY is required to bring THE PROPERTY into compliance with Riverside County Ordinance No. 541 (RCC Chapter 8.120) and the Health and Safety Code. Under RCO No. 541, no amount of rubbish is allowed to accumulate on THE PROPERTY.
- 17. The Board of Supervisors is requested to issue an Order to Abate the Nuisance described herein. Accordingly, the following findings and conclusions are recommended:
- (a) the accumulation of rubbish on THE PROPERTY to be deemed and declared a public nuisance;
- (b) the OWNER and person(s) in possession of THE PROPERTY be required to remove all accumulated rubbish within ninety (90) days of the date of the posting and mailing of the Board's Order to Abate Nuisance, in accordance with all Riverside County Ordinances, including but not limited to the provisions of County Ordinance No. 541;
- (c) in the event the rubbish is not removed and disposed of according to the above referenced ninety (90) day time period in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance No. 541 (RCC Chapter 8.120), the rubbish shall be abated by representatives of the Riverside County Code Enforcement Department, a contractor or the Sheriff's Department; and
