#### BACKGROUND:

The Board ordered the property owner to abate the violative conditions on the property and directed County Counsel to prepare the Findings of Fact, Conclusion and Order to Abate.

## SUMMARY OF EVIDENCE

- 1. Documents of record in the Riverside County Recorder's Office identify the OWNER of THE PROPERTY as Jacqueline D. Downer ("OWNER").
- 2. Documents of title indicate that additional parties may potentially hold a legal interest in THE PROPERTY, to-wit: Wells Fargo Home Mortgage, Inc. and Fidelity National Title Insurance ("INTERESTED PARTIES").
- 3. THE PROPERTY was inspected by Code Enforcement Officers on March 6, 2009, May 18, 2009, July 2, 2009, August 10, 2009, October 26, 2009, January 22, 2010, March 16, 2010 and May 17, 2010.
- During each inspection, an accumulation of rubbish was observed on THE PROPERTY. The rubbish consisted of, but was not limited to: wood, metal, used vehicle parts, household trash, tires, plastic and miscellaneous debris.
- 5. THE PROPERTY was determined to be in violation of Riverside County Ordinance No. 541 (RCC Chapter 8.120) by the Code Enforcement Officer.
- 6. A Notice of Noncompliance was recorded in the Office of the County Recorder, County of Riverside, State of California on May 29, 2009 as instrument number 2009-0272140.
- 7. On March 6, 2009, a Notice of Violation was posted on THE PROPERTY. On March 10, 2009, a Notice of Violation was mailed to OWNER by certified mail, return receipt requested. On June 10, 2009, a Notice of Violation was mailed by certified mail return receipt requested to OWNER and INTERESTED PARTIES.
- 8. On March 15, 2010, a "Notice to Correct County Ordinance Violations and Abate Public Nuisance" providing notice of the public hearing before the Board of Supervisors on May 18, 2010, was mailed by certified mail, return receipt requested, to the OWNER and INTERESTED PARTIES and was posted on THE PROPERTY on March 16, 2010.

## **FINDINGS AND CONCLUSIONS**

WHEREFORE, the Board of Supervisors of the County of Riverside, State of California, in regular session assembled on May 18, 2010, finds and concludes that:

WHEREAS, the accumulation of rubbish on the real property located at One Parcel

South East of 56498 Benton Way, Anza, Riverside County, California, also identified as Assessor's Parcel Number 573-260-012 violates Riverside County Ordinance No. 541 and constitutes a public nuisance.

- 2. WHEREAS, THE OWNER, or any person having possession or control of the premises should abate the condition by removing and disposing all accumulated rubbish from the subject real property in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance No. 541 (RCC Chapter 8.120) within ninety (90) days.
- 3. WHEREAS, THE OWNER AND INTERESTED PARTIES ARE HEREBY FURTHER NOTICED that the time within which judicial review of the administrative determinations made herein must be sought is ninety (90) days from the posting and mailing of the Findings of Fact, Conclusions and Order To Abate Nuisance, and is governed by California Code of Civil Procedure Section 1094.6.

## **ORDER TO ABATE NUISANCE**

IT IS THEREFORE ORDERED that the accumulation of rubbish on THE PROPERTY be abated by THE OWNER or anyone having possession or control of THE PROPERTY, by removing and disposing of all rubbish from the subject real property in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance No. 541 (RCC Chapter 8.120) within ninety (90) days of the date of this Order to Abate Nuisance.

IT IS FURTHER ORDERED that if the rubbish is not removed and disposed of in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance No. 541, within ninety (90) days of the date of this Order to Abate Nuisance, the rubbish shall be abated and disposed of by representatives of the Riverside County Code Enforcement, a contractor or the Sheriff's Department upon receipt of an owner's consent or a Court Order authorizing entry onto THE PROPERTY when necessary under applicable law.

IT IS FURTHER ORDERED that reasonable abatement costs, after notice and opportunity for hearing, shall be imposed as a lien on THE PROPERTY, which may be collected as a special assessment against THE PROPERTY pursuant to Government Code section 25845 and Riverside County Ordinance Nos. 541 and 725. Under Riverside County Ordinance No. 725, "abatement costs" means "any costs or expenses reasonably related to the abatement of conditions which violate County Land Use Ordinances, and shall include, but not be limited to, enforcement, investigation, collection and administrative costs, attorneys fees, and the costs associated with the removal or correction of the violation." Reasonable abatement costs accrued by the Code Enforcement Department will be recoverable from the property owner(s) even if THE PROPERTY is brought into compliance within ninety (90) days of the date of this Order to Abate Nuisance.


