23	L. Alexandra Fong, Deputy County Counsel, appeared along with Brian Black, Supervising			
24	Code Enforcement Officer, on behalf of the Director of the Code Enforcement Department.			
25	No one appeared on behalf of Owner.			
26	The Board of Supervisors received the Declaration of the Code Enforcement Officer together			
27	with attached Exhibits, evidencing the excessive outside storage of materials and accumulation of

County Code Chapter 17.32) and 541 (Riverside County Code Chapter 8.120) and as a public nuisance.

SUMMARY OF EVIDENCE

- Documents of record in the Riverside County Recorder's Office identify the owner of 1. THE PROPERTY as Marie B. Boulanger ("OWNER").
- Documents of title indicate that other parties potentially hold a legal interest in THE 2. PROPERTY, to wit: MERS, Financial Freedom Senior Funding Corporation and Riverside County Redevelopment Agency (hereinafter collectively referred to as "INTERESTED PARTIES").
- THE PROPERTY was inspected by Code Enforcement Officers on May 26, 2009, 3. June 24, 2009, August 4, 2009, September 21, 2009, December 21, 2009, March 18, 2010 and May 14, 2010.
- 4. During each inspection, the outside storage of materials and accumulation of rubbish were observed on THE PROPERTY. The materials and rubbish were intermingled and included but were not limited to: discarded appliances, screen doors, patio furniture, dressers, shelving, cases, plastic storage tubs, yard tools & equipment, mattresses, linens, blankets, sleeping bags, clothes, lamps, toilets, sinks, antennae, scrap wood and metal, and other miscellaneous trash and debris. The officer measured the area and determined the amount of accumulated rubbish and excess outside storage was approximately one thousand seven hundred forty-six (1,746) square feet. Given the size of the parcel (1.16 acres) and the zoning classification (R-A, Residential Agricultural), two hundred (200) square feet of outside storage and no amount of rubbish is allowed on THE PROPERTY.
- 5. THE PROPERTY was determined to be in violation of Riverside County Ordinance Nos. 348 (RCC Chapter 17.32) and 541 (RCC Chapter 8.120) by the Code Enforcement Officer.
- 6. A Notice of Noncompliance was recorded on August 25, 2009, as Document Number 2009-0443816 in the Office of the County Recorder, County of Riverside.
- On May 26, 2009, Notices of Violation for violation of Riverside County Ordinance 7. Nos. 348 and 541 were posted on THE PROPERTY. On May 29, 2009, Notices of Violations were mailed to OWNER and on October 5, 2009, Notices of Violation were mailed to OWNER and INTERESTED PARTIES by certified mail, return receipt requested.

8. On March 17, 2010, the "Notice to Correct County Ordinance Violations and Abate Public Nuisance" providing notice of the public hearing before the Board of Supervisors scheduled for May 18, 2010, was mailed by certified mail, return receipt requested, to OWNER and INTERESTED PARTIES and was posted on THE PROPERTY on March 18, 2010.

FINDINGS AND CONCLUSIONS

WHEREFORE, the Board of Supervisors of the County of Riverside, State of California, in regular session assembled on May 18, 2010, finds and concludes that:

- 1. WHEREAS, the excess outside storage of materials and accumulation of rubbish on the real property located at 18480 Mermac Road, Lake Elsinore, Riverside County, California, also identified as Assessor's Parcel Number 347-040-043 violates Riverside County Ordinance Nos. 348 (RCC Chapter 17.32) and 541 (RCC Chapter 8.120) and constitutes a public nuisance. Under Riverside County Ordinance No. 348, two hundred (200) square feet of outside storage of materials is allowed to be stored on THE PROPERTY. Under Riverside County Ordinance No. 541, no amount of rubbish is allowed to be accumulated on THE PROPERTY.
- 2. WHEREAS, THE OWNER, occupants or any person having possession or control of the premises should abate the condition by removal of all outside storage of materials in excess of two hundred (200) square feet and removing and disposing of all accumulated rubbish from the subject real property in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance Nos. 348 (RCC Chapter 17.32) and 541 (RCC Chapter 8.120) within ninety (90) days.
- 3. WHEREAS, THE OWNER IS HEREBY FURTHER NOTICED that the time within which judicial review of the administrative determinations made herein must be sought is ninety (90) days from the posting and mailing of the Findings of Fact, Conclusions and Order To Abate Nuisance, and is governed by California Code of Civil Procedure Section 1094.6.

ORDER TO ABATE NUISANCE

IT IS THEREFORE ORDERED that the excess outside storage of materials and accumulation of rubbish on THE PROPERTY be abated by the OWNER, Marie B. Boulanger, or anyone having possession or control of THE PROPERTY, by removing all of the outside storage of

materials in excess of two hundred (200) square feet and removing and disposing of all accumulated rubbish from the subject real property in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance Nos. 348 (RCC Chapter 17.32) and 541 (RCC Chapter 8.120) within ninety (90) days of the date of this Order to Abate Nuisance.

IT IS FURTHER ORDERED that if the materials and rubbish are not removed and disposed of in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance Nos. 348 (RCC Chapter 17.32) and 541 (RCC Chapter 8.120) within ninety (90) days of the date of this Order to Abate Nuisance, the excess outside storage of materials and accumulation of rubbish shall be abated and disposed of by representatives of the Riverside County Code Enforcement Department, a contractor or the Sheriff's Department upon receipt of an owner's consent or a Court Order when necessary under applicable law.

IT IS FURTHER ORDERED that reasonable abatement costs, after notice and opportunity for hearing, shall be imposed as a lien on THE PROPERTY, which may be collected as a special assessment against THE PROPERTY pursuant to Government Code section 25845 and Riverside County Ordinance Nos. 348 (RCC Title 17), 541 (RCC Title 8), and 725 (RCC Chapter 1.16). Under Riverside County Ordinance No. 725, "abatement costs" means "any costs or expenses reasonably related to the abatement of conditions which violate County Land Use Ordinances, and shall include, but not be limited to, enforcement, investigation, collection and administrative costs, attorneys fees, and the costs associated with the removal or correction of the violation." Reasonable abatement costs accrued by the Code Enforcement Department will be recoverable from the property 111


