Center. The tabulation shows that votes representing 1 parcel out of a possible 1 were cast, and that 1 vote (or 100%) was cast against the annexation of Zone 127 to L&LMD No. 89-1-C and the levy and enrollment of the special assessment. Pursuant to Section 22593 of the Streets and Highways Code, this represents a majority protest and the proceedings for the annexation of Zone 127 must be abandoned.
