- If Thomasinia S. Marshall, or anyone having possession or control of the inoperative vehicles and/or vehicle parts do not properly abate the public nuisance within ninety (90) days of the posting and mailing of the Board's Order, a designated representative of the Code Enforcement Department, a towing contractor and/or Sheriff's Department representative shall abate the public nuisance by removal and destruction pursuant to RCO No. 520 (RCC Chapter 10.04) and applicable laws.

- 6. I am informed and believe and thereon allege that on June 3, 2008, Senior Code Officer Starkweather, and Officers Cruz, Wiggins, Kirchoff and Code Technician Diaz drove to THE PROPERTY to conduct an inspection. They were met at the front of THE PROPERTY by the OWNERS who granted them permission onto THE PROPERTY to conduct their inspection. They inventoried and photographed all of the inoperable vehicles, which totaled eight (8). True and correct photographs taken during the inspection that depict the inoperative condition of each vehicle are attached hereto as part of Exhibit "D" and incorporated herein by reference.
- 7. A Vehicle Investigation Inventory and Abatement Report, identifying each inoperative vehicle and the vehicle condition is attached hereto and incorporated herein by reference as part of Exhibit "E."
- 8. Based upon my experience, knowledge and observations, the inoperative, wrecked or dismantled vehicles constitute a public nuisance in violation of the provisions set forth in Riverside County Ordinance Number 520 (RCC Chapter 10.04) in that they are not lawfully enclosed in a building and are not stored or parked in connection with the business of a licensed dismantler, licensed vehicle dealer, a junk dealer or other lawfully conducted business or commercial enterprise.
- 9. On June 17, 2008 a "Notice of Intention to Abate and Remove an Abandoned, Wrecked, Dismantled or Inoperative Vehicle or Parts Thereof" was mailed via certified, return receipt requested, to the PROPERTY OWNER and the identifiable registered owners of the vehicles at the addresses as listed with the California Department of Motor Vehicles (DMV). As part of the inventory, if the vehicle identification number or license plate of a vehicle was ascertainable, the Code Enforcement Department contacted the DMV for the name and address of the registered owner of the inoperative vehicle. Based upon information obtained from the DMV, I am informed and believe that the last registered owners of the inoperative vehicles located on THE PROPERTY (hereinafter cumulatively referred to as "ALL REGISTERED OWNERS") were identified and provided the notice. True and correct copies of the notice,

the proof of service and supporting documentation are attached hereto as Exhibit "F" and are incorporated herein by this reference.

- I am informed and believe and thereon allege that on June 18, 2008, Officer Wiggins drove to THE PROPERTY and posted a "Notice of Intention to Abate and Remove an Abandoned, Wrecked, Dismantled or Inoperative Vehicle or Parts Thereof." True and correct copies of the notice and supporting documentation are attached hereto as Exhibit "F" and are incorporated herein by this reference.
- 11. At the request of the PROPERTY OWNER, an Administrative Hearing was scheduled for July 31, 2008. Michael Soccio presided as hearing officer. At the hearing, Code Enforcement Officer Cruz orally requested that three (3) of the vehicles, numbers 2, 3 and 8, be removed from the abatement proceeding due to insufficient evidence.
- Decision was mailed to the PROPERTY OWNER. The hearing officer's decision was in favor of the County of Riverside. The decision stated that Riverside County Code Enforcement shall have the authority to abate and remove all eight (8) vehicles as identified in the attached Vehicle Investigation Inventory and Abatement Report located on THE PROPERTY. A true and correct copy of the Hearing Decision/Order is attached hereto as Exhibit "G" and is incorporated herein by this reference.
- 13. Based on information and belief which I believe to be true, on August 4, 2008, Code Enforcement received a letter from PROPERTY OWNER, Thomasinia S. Marshall dated August 4, 2008, requesting an appeal to the Board of Supervisors. A true and correct copy of the letter is attached hereto as Exhibit "H" and is incorporated herein by reference.
- 14. On September 25, 2008, I conducted a follow-up inspection of THE PROPERTY, which revealed that three (3) vehicles listed on the inventory report remained. From the road right of way I observed vehicles #2, #4 and #5 on THE PROPERTY in violation of RCO No. 520. True and correct photographs taken during the inspection that depict the condition of each vehicle are attached hereto as part of Exhibit "D" and incorporated herein by reference.

True and correct copies of the notices, returned receipt cards, together with the proofs of service, and the affidavits of posting of notices are attached hereto and incorporated herein as Exhibit "J."
- 17. I am informed and believe and based upon said information and belief allege that the PROPERTY OWNER does not have legal authority or permission to store the inoperative, wrecked or dismantled vehicles and vehicle parts on THE PROPERTY.
- 18. The removal or lawful enclosure in a building of all the inoperative vehicles and parts thereof as set forth in the Vehicle Investigation Inventory Abatement Report, attached hereto and incorporated herein as Exhibit "E" is required to bring THE PROPERTY into compliance with Riverside County Ordinance No. 520 (RCC Chapter 10.04).
 - 19. Accordingly, the following findings and conclusions are recommended:
- (a) The vehicles or parts thereof as set forth in the Vehicle Investigation Inventory Abatement Report, attached hereto as Exhibit "E" be found to be abandoned, wrecked, dismantled or inoperative and declared a public nuisance in violation of RCO No. 520, Riverside County Code Chapter 10.04;
 - (b) The Administrative Hearing Order/Decision be affirmed;
- (c) PROPERTY OWNER or anyone having possession or control of the inoperative vehicles or vehicle parts be required to abate the public nuisance by removing or lawfully enclosing in a

- (d) If the above described public nuisance is not abated in strict accordance with all Riverside County Ordinances, including RCO No. 520, within fifteen (15) days after posting and mailing of the Board's Order and Findings, a designated representative of the Riverside County Code Enforcement Department, a towing contractor and/or Sheriff's Department representative shall abate the public nuisance by removal and destruction of the inoperative vehicles and vehicle parts pursuant to Riverside County Ordinance No. 520 (RCC Chapter 10.04) and applicable laws upon receipt of an owner's consent or Court Order where necessary under applicable law;
- (e) That reasonable costs of abatement, after notice and opportunity for hearing, shall be imposed as a lien on THE PROPERTY, which may be collected as a special assessment against THE PROPERTY pursuant to Government Code Section 25845 and Riverside County Ordinance Nos. 520 and 725.







A Code Enforcement Administrative Hearing was conducted on July 31, 2008, at 4080 Lemon Street, Riverside, Ca., to determine if the cited party is/are in violation of the above-referenced Riverside County Code. Thomasinia S. Marshall was accompanied by Gary Marshall, who provided testimony.

Facts:

Code Enforcement Officer Jose Cruz and Britt Starkweather substantiated the violation through photographs for each unit and personal testimony.

The necessary service of all required notices was established by the officer, and included file copies of Notice of Intention to Abate and Remove an Abandoned, Wrecked, Dismantled or Inoperative Vehicle or Parts Thereof; photographs for each unit investigated, Proof of Service by certified mail; Notice of Hearing and Proof of Service by mail for Notice of Hearing.

Mr. Marshall indicated that three of the vehicles are operable, and this can be verified upon follow up inspection.

Decision:

Based on the facts presented, I find in favor of the County of Riverside cited party and declare that the vehicles described herein constitute a public nuisance under Riverside County ordinances.

Thomasinia S. Marshall is hereby directed to abate the vehicles described above no later than August 18, 2008. Thomasinia S. Marshall will provide full access to Riverside County Code Enforcement Officers to verify compliance at approximately 9:00a.m. on that day, including proving operability of any alleged vehicles. If these actions are not taken by the stipulated date, then the County of Riverside shall have full authority to abate and remove the vehicles, and to recover all administrative costs, including attorney fees, Officer enforcement costs and removal costs as provided under Riverside County Ordinances 520 and 725.

The decision of the Hearing Officer may be appealed by filing a written notice of appeal with the Code Enforcement Department within five (5) days of service of this notice. 


