- 3. If the owners of the real property do not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent or receipt of a Court Order authorizing entry onto the real property when necessary under applicable law, shall abate the excess outside storage and accumulation of rubbish by removing and disposing of the same from the real property.
- 4. The reasonable costs of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance No. 725.
- 5. County Counsel be directed to prepare the necessary Findings of Fact and Conclusions that the excess outside storage of materials and accumulation of rubbish on the real property is declared to be in violation of Riverside County Ordinance Nos. 348 and 541, and a public nuisance, and further, to prepare an Order to Abate for approval by the Board.

JUSTIFICATION:

- 1. An initial inspection was made of the subject property by the Code Enforcement Officer on August 31, 2009.
- 2. The inspection revealed the excess outside storage of materials and an accumulation of rubbish on the subject property in violation of Riverside County Ordinance Nos. 348 and 541. The items included but were not limited to: tile, rocks, brick, fencing, window panes, furniture, appliances, scrap wood, green waste, tires, wood, blocks, flooring, a table saw and stove, and household trash.
- 3. Subsequent follow up inspections of the above-described real property on December 10, 2009, January 27, 2010, February 24, 2010 and April 29, 2010, revealed that the property continued to be in violation of Riverside County Ordinance Nos. 348 and 541.
- 4. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for the removal of excess outside storage and accumulated rubbish.

- I, Richard Arriola, hereby affirm and declare that the facts set forth below are personally known to me except to the extent that certain information is based on information and belief which I believe to be true, and if called as a witness, I could and would competently testify thereto under oath:
- 1. I am currently employed by the Riverside County Code Enforcement Department as a Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting property for violations and enforcement of the provisions of Riverside County Ordinances.
- 2. On August 31, 2009, Code Enforcement Aide Robles and I conducted an initial inspection of the real property described as 23371 Gertrude Avenue, Perris, Riverside County, California and further described as Assessor's Parcel Number 342-093-010 (hereinafter referred to as "THE PROPERTY"). A true and correct copy of a Thomas Brothers map indicating the location of THE PROPERTY is attached hereto as Exhibit "A."
- 3. A review of County records and documents disclosed that THE PROPERTY is owned by Miguel Sandoval and Leticia Sandoval (hereinafter referred to as "OWNERS"). A certified copy of the County Equalized Assessment Roll for the year 2009-2010 and a copy of the report generated from the County Geographic Information System ("GIS") is attached hereto and incorporated herein by reference as Exhibit "B." THE PROPERTY is located within the R-R (Rural Residential) zone classification. This zone classification allows outside storage on an improved parcel with the amount of storage to be two hundred (200) square feet for properties that are a minimum of one acre in size. THE PROPERTY is approximately 2.39 acres.

- 4. Based upon the Lot Book Reports issued by RZ Title Service on September 10, 2009 and updated on March 11, 2010, it is determined that other parties may potentially hold a legal interest in THE PROPERTY, to wit: Capital One Bank, Beneficial California, Inc., State of California Franchise Tax Board and Tap Trang (hereinafter referred to as "INTERESTED PARTIES"). True and correct copies of the Lot Book Reports are attached hereto as Exhibit "C" and are incorporated herein by reference.
- 5. On August 31, 2009, Code Enforcement Aide Robles and I drove to THE PROPERTY to conduct an inspection. At THE PROPERTY, we made contact with OWNER, Leticia Sandoval, who granted us permission to inspect. I observed excess outside storage and accumulated rubbish on THE PROPERTY. Using the pacing method, I measured the affected areas and determined the amount of outside storage of materials and accumulated rubbish to be twenty thousand eight hundred (20,800) square feet. The outside storage of materials and accumulated rubbish were intermingled and consisted of but were not limited to: tile, rock, bricks, fencing, window panes, furniture, appliances, scrap wood, green waste, tires, wood, blocks, flooring, a table saw and stove, and household trash. I also observed a shipping container.
- 6. As a result of the excess outside storage of materials and accumulated rubbish, THE PROPERTY constituted a public nuisance in violation of the provisions set forth in Riverside County Ordinance ("RCO") No. 348 as codified in Riverside County Code ("RCC") Chapters 17.16 and 17.288 and RCO No. 541, as codified in RCC Chapter 8.120.
- 7. On August 31, 2009, Notices of Violation for the excess outside storage of materials, accumulated rubbish, and shipping container were posted on THE PROPERTY.
- 8. On September 29, 2009 and January 7, 2010, Notices of Violation were mailed to OWNERS and on September 29, 2009, were mailed to INTERESTED PARTIES by certified mail, return receipt requested.
- 9. On December 10, 2009, I conducted a follow-up inspection with the permission of OWNER. I observed that there had been some clean up, but THE PROPERTY remained in violation of RCO 348 (RCC Chapters 17.16 and 17.288) and 541 (RCC Chapter 8.120) and all prior measurements were still valid.

- On January 27, 2010 and February 24, 2010, from the road right of way, I conducted 10. follow-up inspections on THE PROPERTY. The inspections revealed the excess outside storage, shipping container and accumulated rubbish remained on THE PROPERTY in violation of RCO 348 (RCC Chapters 17.16 and 17.288) and 541 (RCC Chapter 8.120). During each inspection, I observed no change in the amount of rubbish or storage on THE PROPERTY.
- A site plan and photographs depicting the condition of THE PROPERTY during the 11. above referenced inspections are attached hereto as Exhibit "D" and are incorporated herein by reference.
- True and correct copies of each Notice issued in this matter and other supporting 12. documentation are attached hereto as Exhibit "E" and incorporated herein by reference.
- Based upon my experience, knowledge and visual observations, it is my determination 13. that the conditions on THE PROPERTY are dangerous to the neighboring property owner and the general public.
- I am informed and believe and based upon said information and belief allege that 14. OWNERS do not have legal authority or permission to store or accumulate the above described materials on THE PROPERTY.
- A Notice of Non-Compliance was recorded in the Office of the County Recorder, County 15. of Riverside, State of California, on January 21, 2010, as Instrument Number 2010-0025171, a true and correct copy is attached hereto and incorporated herein by reference as Exhibit "F".
- On April 22, 2010, I conducted a follow-up inspection on THE PROPERTY which 16. revealed that the shipping container had been removed.
- On April 29, 2010, I conducted a follow-up inspection on THE PROPERTY that revealed 16. the excess outside storage and accumulated rubbish remained on THE PROPERTY in violation of RCO 348 (RCC Chapters 17.16) and 541 (RCC Chapter 8.120).
- On April 28, 2010, the second notice "Notice to Correct County Ordinance Violations 17. and Abate Public Nuisance" providing notification of the Board of Supervisors' hearing scheduled for june 15, 2010, as required by Riverside County Ordinance No. 725, was mailed to OWNERS and INTERESTED PARTIES by certified mail, return receipt requested and on April 29, 2010, was posted 3

on THE PROPERTY. True and correct copies of the notice, returned receipt cards, together with the proof of service, and the affidavit of posting of notices are attached hereto as Exhibit "G" and incorporated herein by reference.


- 18. The removal of all excess outside storage of materials and the removal of accumulated rubbish currently on THE PROPERTY is required to bring THE PROPERTY into compliance with Riverside County Ordinance Nos. 348, 541 and the <u>Health and Safety Code</u>. Given the size of the parcel and the zoning classification, two hundred square feet of outside storage is allowed on THE PROPERTY under RCO No. 348. Under RCO No. 541, no amount of rubbish is allowed to be accumulated on THE PROPERTY.
 - 19. Accordingly, the following findings and conclusions are recommended:
- (a) the excess outside storage of materials and accumulated rubbish on THE PROPERTY be deemed and declared a public nuisance; and
- (b) the OWNERS or whoever has possession or control of THE PROPERTY be required to remove all excess outside storage of materials in excess of two hundred square feet and accumulated rubbish on THE PROPERTY in accordance with the provisions of RCO Nos. 348 and 541.
- (c) that if the materials and rubbish are not removed and disposed of in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance Nos. 348 and 541, within ninety (90) days of the date of the Order to Abate Nuisance, the excess outside storage of materials and accumulated rubbish shall be abated and disposed of by representatives of the Riverside County Code Enforcement Department, a contractor or the Sheriff's Department upon receipt of an owner's consent or a Court Order when necessary under applicable law.

(d) that reasonable costs of abatement, after notice and opportunity for hearing, shall be imposed as a lien on THE PROPERTY, which may be collected as a special assessment against THE PROPERTY pursuant to Government Code Section 25845 and Riverside County Ordinance Nos. 348 and 725.












