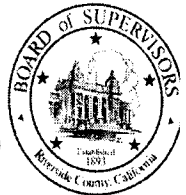

The Well in the Desert is a non -profit organization located in Palm Springs that assists people in need. This funding will support the food program during the summer.


The California Desert Association Annual forum features speakers on topics like lending, property values, and the local market. This funding is for sponsorship of this event.

These community based events and organizations provide services to 4th District residents and I request that the Board support these uses of Community Improvement Designation funds.


