**SUBJECT:** Approve, in accordance with Riverside County Ordinance 440, the extension of the employment for Student Aide II positions for the Riverside County Department of Mental Health, Substance Abuse Friday Night Live Program.

**RECOMMENDED MOTION:** Move that the Board of Supervisors ratify and approve, in accordance with Riverside County Ordinance 440, the extension of employment for the Student Aide II positions for the Riverside County Department of Mental Health (DOMH), Substance Abuse Friday Night Live (FNL) Program for FY 2009/2010 and FY 2010/2011.

**BACKGROUND:** Historically, the Riverside County FNL Program has employed Student Aide II's to serve as FNL Chapter Liaisons between Riverside County FNL and the School Districts located throughout Riverside County. These positions consist of students in local Colleges and Universities who work with the Riverside County FNL Program while completing their College education.

**SUBJECT:** Approve, in accordance with Riverside County Ordinance 440, the extension of the employment for Student Aide II positions for the Riverside County Department of Mental Health, Substance Abuse Friday Night Live Program.

**BACKGROUND: (cont'd)**

Student Aide II positions require extensive on the job training by seasoned FNL Staff. This training process takes approximately two months to complete before a Student Aide is equipped to provide the required level of expertise and service to the local FNL Chapters. In order to effectively serve these chapters, additional hours of work are needed for the Student Aide to meet the requirements of the Riverside County FNL Program, and the Federal Substance Abuse Prevention Treatment (SAPT) Block Grant. These positions are limited in the number of hours they can work in accordance with Riverside County Ordinance 440. Therefore, in accordance with Riverside County Ordinance 440, the Riverside County DOMH is requesting that the Riverside County Board of Supervisors authorize the extension of the Student Aide II positions working for the DOMH, Substance Abuse Friday Night Live Program to work more than one thousand (1000) hours for FY 2009/2010 and FY 2010/2011.

**FINANCIAL IMPACT:**

The Student Aide II positions are paid for with 100% Federal SAPT Block Grant Funds. In addition, the positions are fully budgeted in the DOMH, Substance Abuse Program for FY 2009/2010, and no additional County funds are required.

**PERIOD OF PERFORMANCE:**

The period of performance for this request is for the current and upcoming fiscal year (FY 2009/2010 through FY 2010/2011).
