RECOMMENDED MOTION: That the Board of Supervisors reject all bids received for the Resurfacing and Reconstruction Project of five roads, Coachella Valley area.

BACKGROUND: By Minute Order dated December 15, 2009 (agenda item 3.22) the Board authorized the Clerk of the Board to advertise for the resurfacing and reconstruction project of five roads in the Coachella Valley area. Bids for the project were opened in the office of the Director of Transportation at 2:00 PM, Wednesday, January 13, 2010. Five bids were received, ranging from \$2,631,362.00 to \$3,849,948.00. The engineer's estimate was \$2,945,000.00.

Shortly before the opening of bids, Caltrans began construction on the Bob Hope Interchange project. After the bids were opened, Caltrans informed the Transportation Department that the interchange contractor would be transporting materials on Varner Road and Rio del Sol Road. The interchange Contractor's start date, duration and number of trips could not be determined, but it could be several hundred trips per day and would include round the clock trucking. The County's contract included full closure of each half of Varner Road for up to seven days, but required the contractor to maintain continual access to all the local businesses.

The combination of constraints from the Caltrans interchange project and the County rehabilitation project, make construction of both projects at the same time impractical.

The work on Varner Road and Rio del Sol Road comprise over 60% of the County Resurfacing and Reconstruction project. The project was bid as one project and, cannot be separated into smaller projects and there continues to be issues that affect the Caltrans contractor's sequencing of work.

Based on these finding, the Transportation Department recommends that all bids be rejected.

The Transportation Department intends to bid the five roads as two separate projects as follows:

Project 1 – Re-advertise in summer 2010

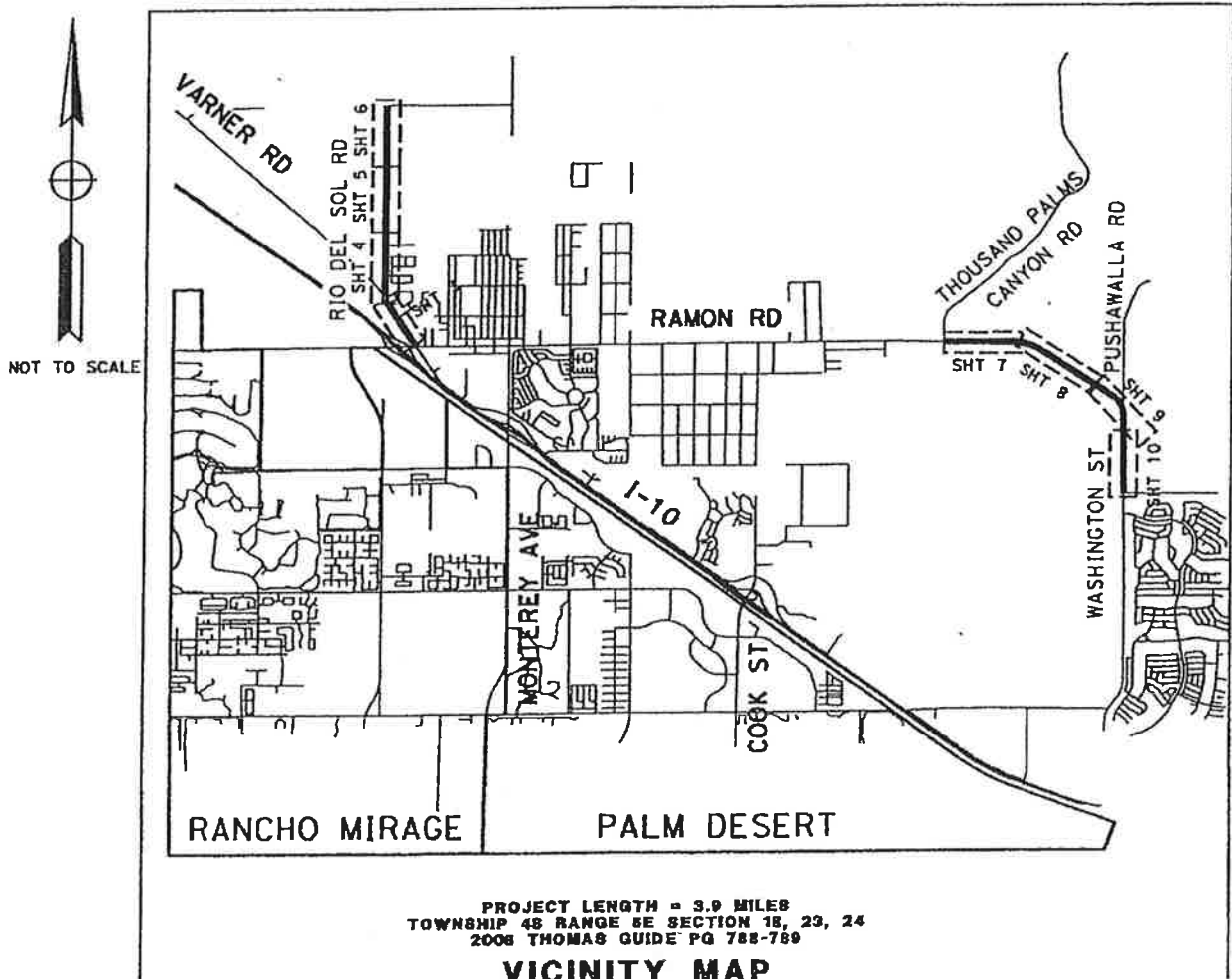
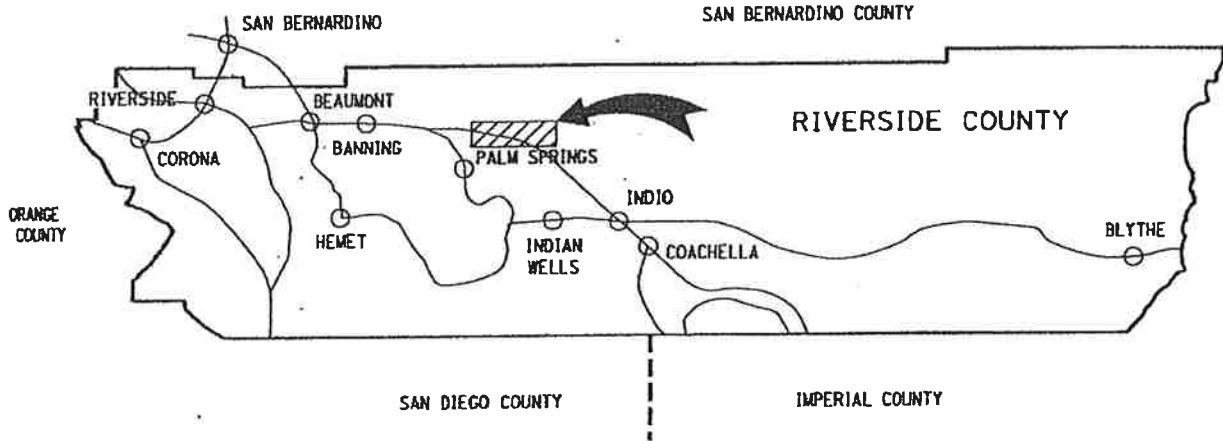
VICINITY MAP
