

**BACKGROUND:**

The Desert Recreation District provides youth summer programs at the Thousand Palms Community Center and the Mecca Community Center.

The Blythe Emergency Food Pantry distributes food to low income families in the Palo Verde Valley.

The Riverside County Regional Medical Center Foundation's 2010 Festival of Trees event raises funds to purchase desperately needed and often life saving equipment for the Medical Center.

Soldiers Organized Services provides transportation for service men and women arriving at Palm Springs International Airport. Volunteers provide the vehicles. However, funds are needed to purchase gasoline for these volunteers.

The Volunteer Center of Riverside County provides information, referrals, and resources to residents in the Coachella Valley.
