Annual Report 2009

MEETINGS:

The Riverside County Historical Commission held six regular meetings in 2009.

ACTIONS TAKEN:

- ❖ Certificates were provided to winning students of the Riverside County History Day.
- ❖ The Commission recommended that the Riverside County Landmark application for the North Shore Yacht Club be favorably considered by the Board of Supervisors. The Board voted their approval of landmark status for this building in September 2009.
- ❖ The Commission elected a new Chair and Vice-Chair for the year.
- ❖ The Commission voted to begin publication of a county history journal to be issued twice annually. The journal is to be called, *The Riverside County Chronicles: A Journal of the History of Riverside County, California*. Issue No. 1 was published last spring and Issue No. 2 will be out in June 2010.
- ❖ The Commission voted to send a letters to the cities of Indio and Indian Wells expressing concern of the demolition of two historically significant buildings; the Mullin House and the Carl Gray Gallery.
- ❖ The Commission recommended that the Riverside County Landmark application for the Bryant House AKA: Hotel Banning, San Geronio Inn be favorably considered as a County Historic Landmark by the Board of Supervisors.
- ❖ The Commission recommended that the Riverside County Landmark application for the Eden Hot Springs site be favorably considered as a County Historic Landmark by the Board of Supervisors.

OTHER ITEMS OF INTEREST:

- ❖ Approximately 9,000 copies of the county landmarks map/brochure, *Historic Riverside County Adventures*, have been distributed.
- ❖ HPO Herron continued to work with the Planning Department on the proposal for a historic preservation district in Idyllwild. A consultant conducted a historic resources survey of the Idyllwild business district, and recommendations for the formation of a district are now being considered. Revisions to the ordinance that authorizes such districts are being proposed to the Board of Supervisors. The Historical Commission will review any district applications and forward them on to County Planning with their recommendations.
- ❖ Annual History Awards given by the Commission for Individual Achievement went to Joan H. Hall and Anne J. Miller.
- ❖ The Commission worked to support the establishment of a Heritage Tourism Consortium for the greater Riverside area (city). This effort has been led by Commissioner John Worden. The Consortium is now firmly established. It promotes heritage tourism through its regular meetings, a website, and information sharing among members in the consortium database.
- ❖ The Commission supported a highly successful event at the Gilman Ranch on the 100th anniversary of the events surrounding the story of Willie Boy.

COMMUNITY INVOLVEMENT


The Historical Commission was involved across the county and in each supervisory district on a variety of historical issues. The following items summarize those activities:

The Trails Committee has worked in partnership with County departments to assure the enhancement of their efforts to provide, protect, and maintain the multi-use trail systems throughout the County.

The Trails Committee expresses appreciation to the Riverside County Regional Park & Open-Space District, Riverside County Transportation and Land Management Agency, Planning, Flood Control District, and the Board of Supervisors for assisting the Trails Committee with its mission to acquire, maintain, and promote equestrian, biking, and hiking recreation trails in Riverside County.

MEETINGS:

The Riverside County Regional Park & Open-Space District Advisory Commission met bimonthly in January, March, May, July, September and November of 2009.

DISTRICT ADVISORY COMMISSION ACTIONS for 2009:

- recommended approval of \$12,041 in Fish and Game fund requests for enhancements to educational programs at Nature Centers throughout Riverside County Park District
- recommended approval of the Regional Park & Open-Space District Use Fees for FY2009-10
- recommended approval of the Trails Committee revision to the Bylaws and Resolution 2009-167
- elected District Advisory Commission officers for FY 2009-10

- recommended approval of a partnership between the Park District and the Department of Fish and Game for the development of a defined historic area in and around the Rancho Santa Rosa area.

COMMISSIONERS & COMMUNITY INVOLVEMENT:

The Commission met in various areas throughout the County in 2009, including Riverside, Murrieta, Idyllwild, and Banning.

District I

Darrell Ruff kept the Commission abreast of activities concerning parks in the Wildomar area. He has been active in the new City of Wildomar.

Bill Hartford frequently visited the Santa Rosa Plateau and is very active with that facility. He also observed activities at Kabian Park. Mr. Hartford served as the Vice-Chair of the Commission for FY 2008/09 and Chair for FY 2009/10. As chair of the District Advisory Commission he assisted the Park District as master of ceremonies at ribbon-cutting events. He also assisted the Park District with the selection process for the Assistant Parks Director position.

District II

Ray Smith is the Public Information Officer for the County of Riverside and has assisted the Park District with media suggestions for many of its events and facilities. He also supported the Wildflower Photo Contest sponsored by the Park District.

District II
