Swanger forged a vision for the future of Southwestern Riverside County while helping to preserve its rich past. Swanger developed key projects in Temecula and was instrumental in protecting the "Wolf Store," one of the county's most important landmarks which dates back to 1868 and served as a post office and main trading post for the region. He also helped save and restore the remaining buildings of the Historic Vail Ranch in Temecula.

Swanger was a patriot who served in the Army before co-founding Mark II Properties in 1975. The company developed tens of millions of dollars in real estate, beginning with residential subdivisions before branching out to commercial projects.

Swanger dedicated himself to his family, working alongside his three sons and traveling the world with his wife Dot.

The Board of Supervisors commemorates his service to the County of Riverside.
