**Whereas** the Riverside County Probation Department is an essential and integral part of the criminal justice system; and,

**Whereas** Probation Officers and Probation Corrections Officers work in partnership with other community agencies and public service organizations in such valuable programs as the Violence Against Women Program, Gang Task Force and the Sexual Offenders Task Force, Youthful Offender Program; and,

**Whereas** the American Probation and Parole Association, has declared July 18 through July 24, 2010, as National American Probation, Parole, and Community Supervision Week, and support a Second Chance; and
