**SUBJECT:** Renewal of the Joint Use Agreement with the Hemet Unified School District for the Joint Use of Library Facilities at the Hamilton High School

**RECOMMENDED MOTION:** That the Board approve and authorize the Chairman to sign the Second Amendment to the Joint Use Agreement between the County of Riverside and the Hemet Unified School District for Joint Use Facilities located at Hamilton High School

**BACKGROUND:** The County Library provides library services to the community of Anza through a joint use library at Hamilton High School, operated in conjunction with Hemet Unified School District. This arrangement has been in place since 1998. On-going library operations are arranged by the County Librarian and maintained with oversight by the County Librarian. Hemet Unified School District provides facilities maintenance services for the Anza Library. This Agreement keeps the same terms and extends the Agreement for an additional year to June 30, 2011, at a cost of \$20.80 per hour, for a total of \$21,632.
