SUBJECT: Approval of the Sixth (6th) Amendment to the Professional Medical Services Agreement between the County of Riverside and Chander P. Malhotra, M.D., Inc.

SIXTH AMENDMENT
TO THE
PROFESSIONAL MEDICAL SERVICES AGREEMENT
BETWEEN
COUNTY OF RIVERSIDE
AND
CHANDER P. MALHOTRA, M.D., INC.

That certain Agreement between the County of Riverside (COUNTY) on behalf of the Riverside County Regional Medical Center (HOSPITAL) and Chander P. Malhotra, M.D., Inc. (CONTRACTOR) dated February 19, 2002, amended effective February 19, 2004, July 1, 2006, February 19, 2007, July 1, 2008, July 1, 2009 is hereby further amended effective July 1, 2010 pursuant to the following:

1. Delete the first (1st) sentence from Section 4.1 and replace with the following:

"This Agreement will be effective July 1, 2010 through June 30, 2011, unless terminated as otherwise provided herein."

All other terms and conditions of this Agreement are to remain unchanged.
