1. The excess outside storage of materials and accumulation of rubbish on the real property located at 31383 Yucca Avenue, Nuevo, Riverside County, California, APN: 426-200-013 be declared a public nuisance and a violation of Riverside County Ordinance Nos. 348 and 541 (Riverside County Code Chapters 17.32 and 8.120).
2. Robert McGinty, Joe N. Jackson and Christopher Jackson, the owners of the subject real property, be directed to abate the excess outside storage and accumulation of rubbish on the property by removing the same from the real property within ninety (90) days.

3. If the owners of the real property do not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent or receipt of a Court Order authorizing entry onto the real property when necessary under applicable law, shall abate the excess outside storage and accumulation of rubbish by removing and disposing of the same from the real property.
4. The reasonable costs of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance No. 725.
5. County Counsel be directed to prepare the necessary Findings of Fact and Conclusions that the excess outside storage of materials and accumulation of rubbish on the real property is declared to be in violation of Riverside County Ordinance Nos. 348 and 541, and a public nuisance, and further, to prepare an Order to Abate for approval by the Board.

JUSTIFICATION:

1. An initial inspection was made of the subject property by Code Enforcement Officers on August 1, 2007.
2. The inspection revealed excess outside storage of materials and an accumulation of rubbish on the subject property in violation of Riverside County Ordinance Nos. 348 and 541. The items included but were not limited to: broken farm equipment, tires, loose hog feed, broken golf carts, 55 gallon barrels, scrap metal, used and discarded lumber, dismantled equipment, cages, shelving, pallets, pipe, fencing, miscellaneous furniture, appliances, green waste, dead vegetation, a collapsed shed, broken gates, tarps, bagged animal feed and other miscellaneous trash and rubbish.
3. Subsequent follow up inspections of the above-described real property on January 31, 2009, July 22, 2009, December 14, 2009, April 16, 2010, May 25, 2010 and June 18, 2010, revealed that the property continued to be in violation of Riverside County Ordinance Nos. 348 and 541.
4. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for the removal of excess outside storage and accumulated rubbish.

8 I, Lori Lyon, hereby affirm and declare that the facts set forth below are personally known to me
9 except to the extent that certain information is based on information and belief which I believe to be
10 true, and if called as a witness, I could and would competently testify thereto under oath.

11 1. I am currently employed by the Riverside County Code Enforcement Department as a
12 Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting
13 property for violations and enforcement of the provisions of Riverside County Ordinances.

14 2. On August 1, 2007, Senior Code Enforcement Officer Keyes, Riverside Sheriff Deputy
15 Wallace, Environmental Health Hazardous Materials Specialist Shalhub, Animal Control Officers
16 Stevens and Huennekens, Code Enforcement Technicians Jurden and Padilla, Code Enforcement
17 Officers Heagstedt, Mc Mullen, Feliciano and I conducted an initial inspection of the real property
18 described as 31383 Yucca Avenue, Nuevo, Riverside County, California and further described as
19 Assessor's Parcel Number 426-200-013 (hereinafter referred to as "THE PROPERTY"). A true and
20 correct copy of a Thomas Brothers map indicating the location of THE PROPERTY is attached hereto
21 as Exhibit "A."

22 3. A review of County records and documents disclosed that THE PROPERTY is owned by
23 Robert McGinty, Joe N. Jackson and Christopher Jackson (hereinafter referred to as "OWNERS"). A
24 certified copy of the County Equalized Assessment Roll for the year 2009-2010 and a copy of the report
25 generated from the County Geographic Information System ("GIS") is attached hereto and incorporated
26 herein by reference as Exhibit "B." THE PROPERTY is located within the R-A (Rural Agricultural)
27 zone classification. This zone classification allows outside storage on an improved parcel with the
28 amount of storage to be two hundred (200) square feet for properties that are a minimum of one-half

1 acre in size. THE PROPERTY is approximately 8.13 acres.

2 4. Based upon the Lot Book Reports issued by RZ Title Service on February 5, 2009 and
3 updated on September 25, 2009 and May 25, 2010, it is determined that other parties potentially hold a
4 legal interest in THE PROPERTY, to wit: State of California Franchise Tax Board, Lilly Jean Brown,
5 Shoshone Service Corporation, Robert B. Stone, The Baralat Company and State of California
6 Employment Development Department (hereinafter referred to as "INTERESTED PARTIES"). True
7 and correct copies of the Lot Book Reports are attached hereto as Exhibit "C" and are incorporated
8 herein by reference.

9 5. On August 1, 2007, Senior Code Enforcement Officer Keyes, Riverside Sheriff Deputy
10 Wallace, Environmental Health Hazardous Materials Specialist Shalhub, Animal Control Officers
11 Stevens and Huennekens, Code Enforcement Technicians Jurden and Padilla, Code Enforcement
12 Officers Heagstedt, Mc Mullen, Feliciano and I drove to THE PROPERTY to conduct an initial
13 inspection pursuant to an inspection warrant. At THE PROPERTY, Deputy Wallace, Senior Code
14 Enforcement Officer Keyes and Code Enforcement Officer Heagstedt made contact with OWNER, Joe
15 Jackson. The remaining County agents waited at a staging area and were called to THE PROPERTY
16 after OWNER gave permission to inspect. I observed excess outside storage and accumulated rubbish
17 on approximately two thirds of THE PROPERTY. The outside storage of materials and accumulated
18 rubbish were intermingled and consisted of but was not limited to: broken farm equipment, tires, loose
19 hog feed, broken golf carts, 55 gallon barrels, scrap metal, used and discarded lumber, dismantled
20 equipment, cages, shelving, pallets, pipes, fencing, miscellaneous furniture, appliances, bagged animal
21 feed, green waste, dead vegetation, a collapsed shed, broken gates, tarps and other miscellaneous trash
22 and debris. The outside storage of materials and accumulated rubbish was scattered throughout the
23 eight (8) acre parcel.

24 6. As a result of the excess outside storage of materials and accumulated rubbish, THE
25 PROPERTY constituted a public nuisance in violation of the provisions set forth in Riverside County
26 Ordinance ("RCO") No. 348 as codified in Riverside County Code ("RCC") Chapter 17.32 and RCO
27 No. 541, as codified in RCC Chapter 8.120.

28 ///

1 7. On August 1, 2007, Notice of Violation for accumulated rubbish was posted on THE
2 PROPERTY. On August 2, 2007, Notice of Violation for excess outside storage of materials was posted
3 on THE PROPERTY.

4 8. On February 9, 2009, Notices of Violation were mailed to the OWNERS by certified
5 mail, return receipt requested. On June 3, 2009 and October 2, 2009, Notice of Violation was mailed to
6 OWNERS and INTERESTED PARTIES by certified mail, return receipt requested.

7 9. On January 31, 2009, Officer Morris and I conducted a follow-up inspection. We entered
8 onto THE PROPERTY through an open front gate. We met foreman, Mr. Blakely, who granted us
9 permission to inspect. I observed that THE PROPERTY remained in violation of RCO 348 (RCC
10 Chapter 17.32) and 541 (RCC Chapter 8.120).

11 10. On July 22, 2009, I conducted a follow-up inspection of THE PROPERTY. I met
12 OWNER, Joe Jackson, who granted me permission to enter and I observed that the excess outside
13 storage and accumulated rubbish remained on THE PROPERTY.

14 11. On December 14, 2009, I conducted a follow up inspection of the property. I entered
15 through open gates and observed the parcel remained in violation. I returned to the parcel on April 16,
16 2010 and met OWNER, Joe Jackson. I observed that a large portion of THE PROPERTY had been
17 cleaned, but approximately one fourth of the accumulated rubbish and excess outside storage remained.

18 12. On May 25, 2010, I conducted a follow up inspection and quantified the amount and type
19 of materials remaining. Using the pacing method, I measured approximately four thousand two hundred
20 twenty four (4,224) square feet of excess outside storage and rubbish remained on THE PROPERTY
21 and consisted of, but was not limited to: vehicle/truck parts, fiberglass shower with enclosure, tires,
22 scrap metal, miscellaneous steel, tractor tire, rubber mat, discarded metal, cables, work benches, used
23 gas cylinders, corral panels, tarps, bags, beams and tires.

24 13. A site plan and photographs depicting the condition of THE PROPERTY during the
25 above referenced inspections are attached hereto as Exhibit "D" and are incorporated herein by
26 reference.

27 14. True and correct copies of each Notice issued in this matter and other supporting
28 documentation are attached hereto as Exhibit "E" and incorporated herein by reference.

1 15. Based upon my experience, knowledge and visual observations, it is my determination
2 that the conditions on THE PROPERTY are dangerous to the neighboring property owner and the
3 general public.

4 16. I am informed and believe and based upon said information and belief allege that the
5 OWNERS and INTERESTED PARTIES do not have legal authority or permission to store or
6 accumulate the above described materials on THE PROPERTY.

7 17. Notices of Non-Compliance were recorded in the Office of the County Recorder, County
8 of Riverside, State of California, on March 5, 2009 as Instrument Numbers 2009-0106115 and 2009-
9 0106117, true and correct copies of which are attached hereto and incorporated herein by reference as
10 Exhibit "F".

11 18. On June 18, 2010, I conducted a follow-up inspection on THE PROPERTY that revealed
12 the excess outside storage and accumulated rubbish remained on THE PROPERTY in violation of RCO
13 348 (RCC Chapter 17.32) and 541 (RCC Chapter 8.120).

14 19. On June 17, 2010, the second notice – "Notice to Correct County Ordinance Violations
15 and Abate Public Nuisance" providing notification of the Board of Supervisors' hearing scheduled for
16 July 13, 2010, as required by Riverside County Ordinance No. 725, was mailed to OWNERS and
17 INTERESTED PARTIES by certified mail, return receipt requested and on June 18, 2010, was posted
18 on THE PROPERTY. True and correct copies of the notice, returned receipt cards, together with the
19 proof of service, and the affidavit of posting of notices are attached hereto as Exhibit "G" and
20 incorporated herein by reference.

21 20. The removal of all outside storage of materials and the removal of accumulated rubbish
22 currently on THE PROPERTY is required to bring THE PROPERTY into compliance with Riverside
23 County Ordinance Nos. 348, 541 and the Health and Safety Code. Given the size of the parcel and the
24 zoning classification, two hundred (200) square feet of outside storage is allowed on THE PROPERTY
25 under RCO No. 348. Under RCO No. 541, no amount of rubbish is allowed to be accumulated on THE
26 PROPERTY.

1 21. Accordingly, the following findings and conclusions are recommended:

2 (a) the outside storage of materials and accumulated rubbish on THE PROPERTY be
3 deemed and declared a public nuisance; and


4 (b) the OWNERS or whoever have possession or control of THE PROPERTY be
5 required to remove all outside storage of materials in excess of two hundred (200) square feet and
6 remove all of the accumulated rubbish on THE PROPERTY in accordance with the provisions of RCO
7 Nos. 348 and 541.

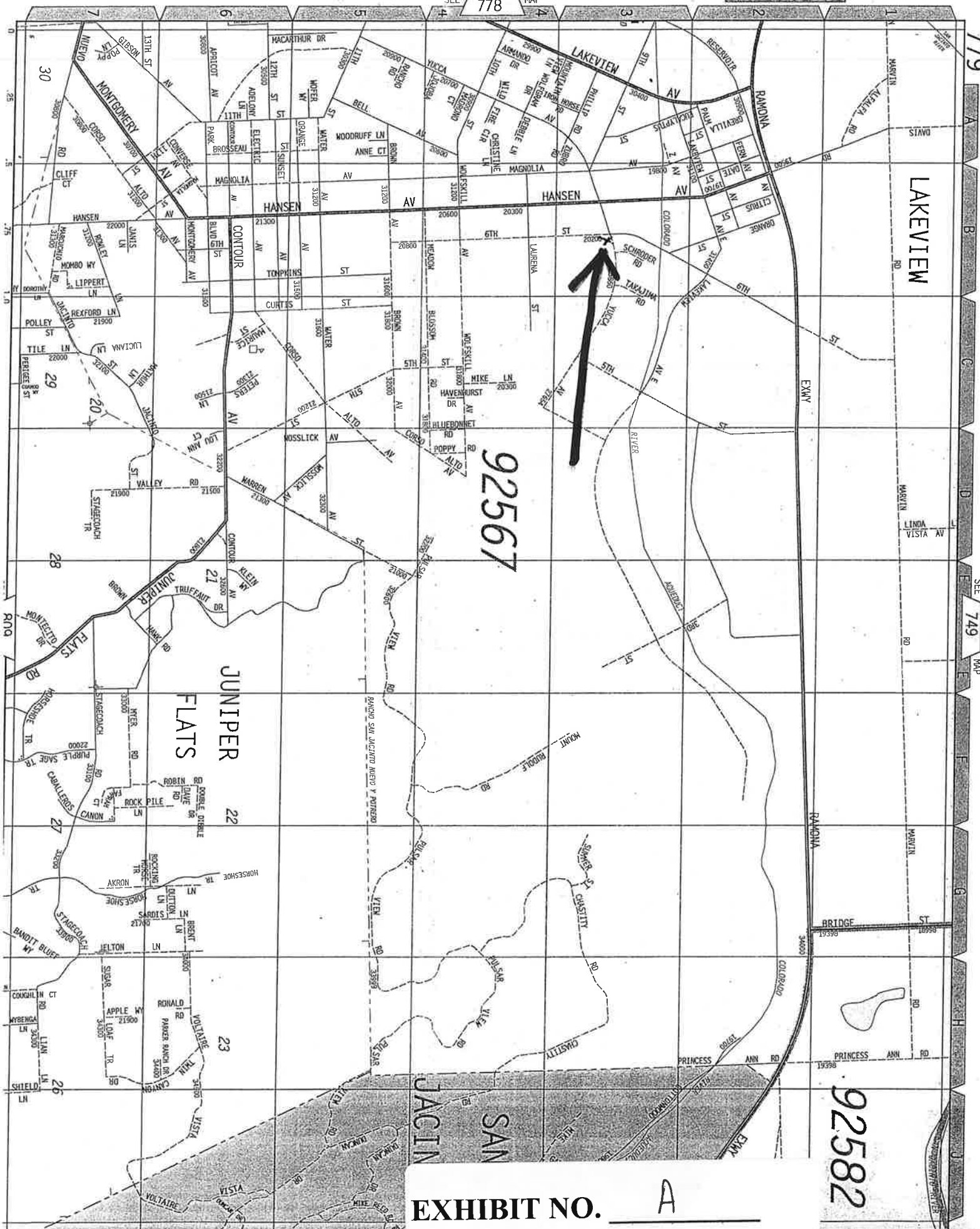
8 (c) that if the materials and rubbish are not removed and disposed of in strict
9 accordance with all Riverside County Ordinances, including but not limited to Riverside County
10 Ordinance Nos. 348 and 541, within ninety (90) days of the date of the Order to Abate Nuisance, the
11 outside storage of materials and accumulated rubbish shall be abated and disposed of by representatives
12 of the Riverside County Code Enforcement Department, a contractor or the Sheriff's Department upon
13 receipt of an owner's consent or a Court Order when necessary under applicable law.

14 (d) that reasonable costs of abatement, after notice and opportunity for hearing, shall
15 be imposed as a lien on THE PROPERTY, which may be collected as a special assessment against THE
16 PROPERTY pursuant to Government Code Section 25845 and Riverside County Ordinance Nos. 348
17 and 725.

18 I declare under penalty of perjury under the laws of the State of California that the foregoing is
19 true and correct.

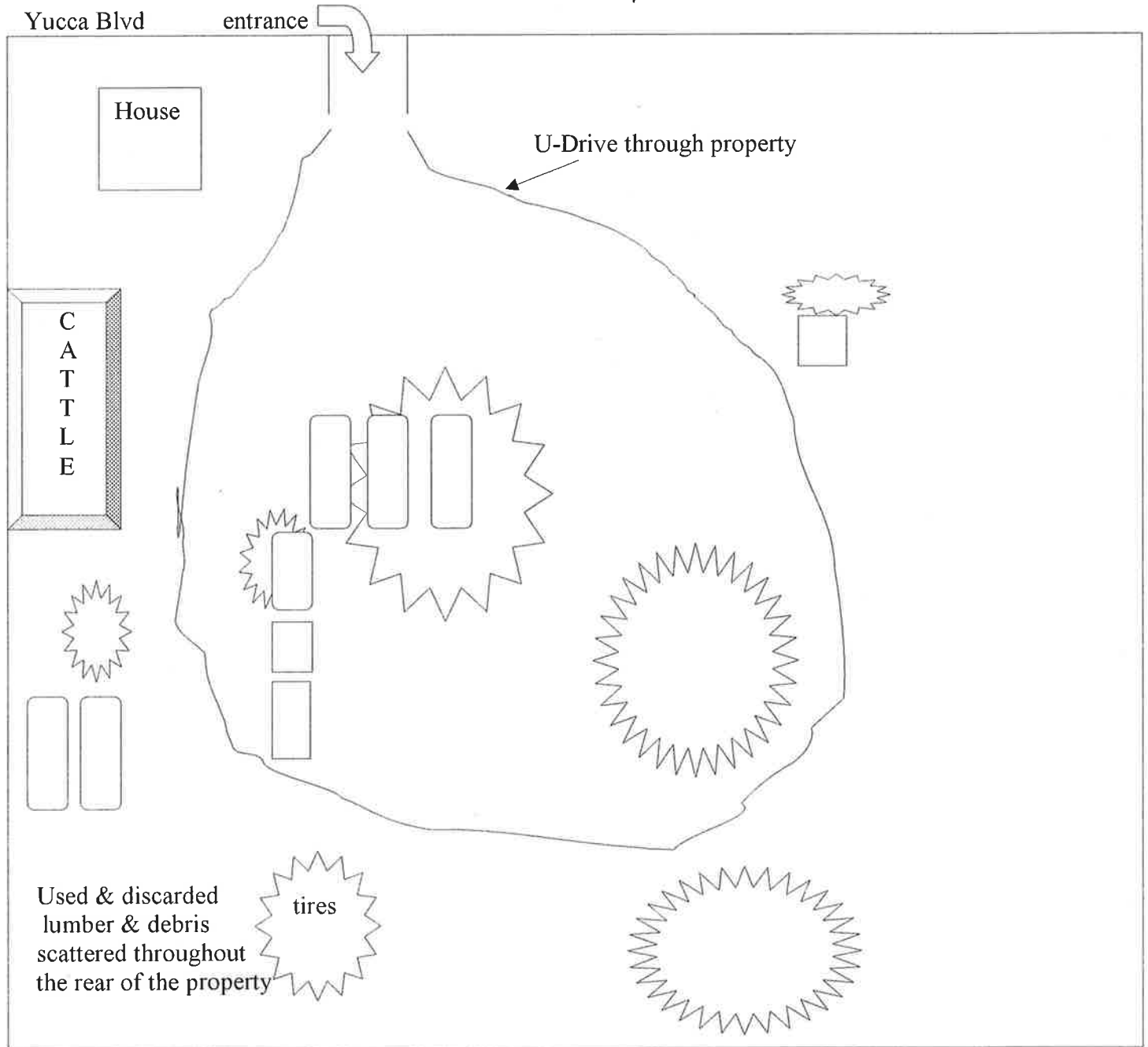

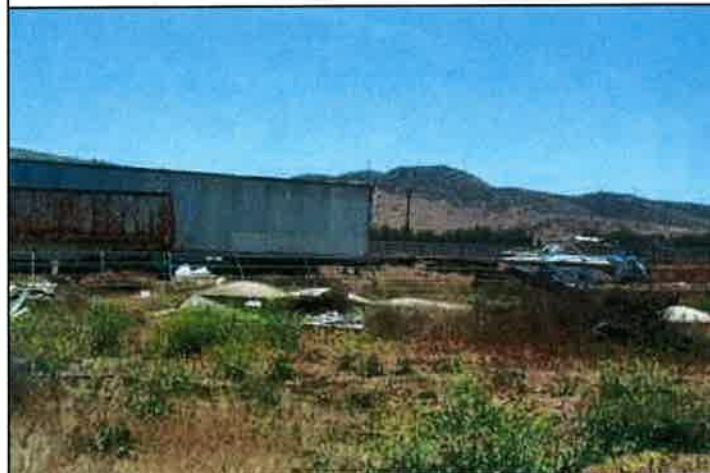
