SUBJECT: Notice of Completion for the Monitoring Well Construction at the Closed Highgrove Sanitary Landfill

RECOMMENDED MOTION: That the Board of Supervisors:

1. Accept the Completion of Monitoring Well Construction at the Closed Highgrove Sanitary Landfill by Layne Christensen Company and authorize the Chairman to execute the attached Notice of Completion; and
2. Direct the County Clerk to file the executed Notice of Completion.


BACKGROUND: On March 16, 2010, the Board awarded Layne Christensen Company the contract for the Completion of Monitoring Well Construction at the Closed Highgrove Sanitary Landfill. On April 26, 2010, the Completion of Monitoring Well Construction at the Closed Highgrove Sanitary Landfill was satisfactorily completed. The final cost for the Completion of Monitoring Well Construction at the Closed Highgrove Sanitary Landfill was \$28,715.00, which is less than the total authorized contract amount of \$36,087.00.
