10 A RESOLUTION OF THE BOARD OF SUPERVISORS, COUNTY OF RIVERSIDE, TO THE  
11 STATE OF CALIFORNIA REQUESTING A GRANT IN THE AMOUNT OF \$564,722 FROM THE  
12 CALIFORNIA DEPARTMENT OF BOATING AND WATERWAYS FOR THE IMPROVEMENT OF  
13 THE BOAT LAUNCHING FACILITY AT MAYFLOWER PARK, LOCATED AT 4980 COLORADO  
14 RIVER ROAD, BLYTHE CA 92225 (Project).

15  
16 WHEREAS, the Department of Boating and Waterways has been delegated the responsibility  
17 by the Legislature of the State of California for the administration of the Boat Launching  
18 Facilities Program, setting up necessary procedures governing the Application; and

20 WHEREAS, said procedures established by the Department of Boating and Waterways require  
21 the Riverside County Parks Department (Applicant) to certify by resolution of the Board of  
22 Supervisors the approval of the application before submission of said application to the State;

25 WHEREAS, the applicant will enter into a contract with the State of California to complete the  
26 Project;

28 NOW, THEREFORE, BE IT RESOLVED that the Riverside County Board of Supervisors  
hereby:

1 Approves the filing of an application for funds for the Mayflower Park Boat Launching Facility  
2 Improvement Project and

- 4 1. Certifies that said applicant has or will have available, prior to commencement of any work  
5 on the project included in this application, the sufficient funds to complete the project should  
6 this grant be awarded; and
- 7 2. Certifies that the applicant has or will have sufficient funds to operate and maintain the  
8 project; and
- 9 3. Certifies that the applicant has reviewed, understands, and agrees to the General Provisions  
10 contained in the contract shown in the Grant Administration Guide; and
- 11 4. Certifies that this project is consistent with the applicable city, county or appropriate planning  
12 document, as the case may be; and
- 13 5. Delegates the authority to the Chair of the Board or its designee, Parks Director, to approve  
14 and sign all agreements and amendments which may be necessary for the completion of the  
15 grant scope; and
- 16 6. Delegates the authority to the Parks Director or designee to conduct all negotiations, sign  
17 and submit all documents, including, but not limited to applications and payment requests,  
18 which may be necessary for the completion of the grant scope; and
- 19 7. Agrees to comply with all applicable federal, state and local laws, ordinances, rules,  
20 regulations and guidelines.
