On June 23, 2010, the Registrar of Voters completed a manual tally of the precincts in the June 8, 2010 Consolidated Primary Election in accordance with Elections Code § 15360. The public was duly noticed on May 26, 2010. The manual tally commenced on June 22, 2010 and concluded on June 23, 2010.
