SUBJECT: Sexual Predator Identification In Riverside County Via Internet Tracking (S.P.I.R.I. T.)

RECOMMENDED MOTION: That the Board of Supervisors approve this proposal to enhance the sexual registrant monitoring system, currently maintained by the State of California, by instituting the additional elements of this proposal.

Background:

Riverside County has been a national leader in knowing the identity and tracking the whereabouts of sexual registrants located in the County. The SAFE (sexual assault felony enforcement) team has been a proactive program in Riverside County ensuring that sexual registrants comply with state reporting laws. As a result of the SAFE team's efforts, 95% of the registered sex offenders in Riverside County are held in compliance with state reporting laws. The remaining five percent may be dead, homeless, or living in other States.

In addition, Riverside County created the SPIDER (sexual predator internet decoy enforcement in Riverside County) program that has successfully arrested and/or convicted over 50 sexual predators attempting to lure young boys and girls via internet conversations. The County has also funded Valley Watch, a successful program that alerts citizens in the Hemet/San Jacinto Valley of sexual registrants moving into their neighborhoods, and to educate parents about appropriate oversight of their children's internet activities. While we have done much to protect the public from these sexual deviants, we can always do more in light of the recent tragic loss of Chelsea King and Amber Dubois in San Diego County.
