SUBJECT: LPS (5150) Designation of Facility for Involuntary Detention of Mentally Disordered Persons for Evaluation and Treatment.

RECOMMENDED MOTION: Move that the Board of Supervisors:

1. Designate Silver Lake Medical Center, a 99 bed inpatient psychiatric facility located at 7500 East Hellman Avenue, Rosemead, California 91770 as a facility for 72-hour treatment and evaluation pursuant to California Welfare and Institutions Code, Section 5150 et. Seq.; and
2. Authorize the Director of the Department of Mental Health to submit the request to the State Department of Mental Health as required by Section 800 et. Seq., Title 9, California Code of Regulations.

BACKGROUND: Silver Lake Medical Center is a General Acute Care Hospital with a 99 bed psychiatric unit. Silver Lake is located in L.A. County, and is currently designated by the State Department of Mental Health as a 5150 receiving facility for L.A. County. Due to an increased need for acute hospital services for County of Riverside constituents with severe mental illness, the Riverside County Department of Mental Health is in need of additional acute hospitalization beds for their patients that are currently receiving treatment at the Riverside County Emergency Treatment Services (ETS) facility, and subsequently requires a 5150 designated facility for continued medical care and mental health treatment. **(Continued on Page 2)**
