FOURTH AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT BETWEEN COUNTY OF RIVERSIDE AND LOMA LINDA UNIVERSITY HEALTHCARE

That certain Agreement between the County of Riverside ("COUNTY") and Loma Linda University Healthcare ("CONTRACTOR") dated January 1, 2006 and amended September 5, 2006, March 16, 2007 AND January 1, 2010, is hereby further amended effective August 1, 2010 pursuant to the following:

- 1. Delete all references to "specialized surgical physicians" and "specialized surgical services" from the Agreement.
- 2. Delete Section 4.1 in its entirety and replace with the following:
 - "This Agreement shall be be effective as of January 1, 2006, and automatically continue on a year-to-year basis, unless terminated as otherwise provided herein. Failure to abide by the agreed terms and conditions may result in immediate termination of the Agreement."
- 3. The language of Exhibit A, Section 3 is deleted in its entirety and replaced as follows:
 - "Maximum annual compensation payable under this Agreement shall not exceed one million eight hundred forty thousand dollars (\$1,840,000)."

All other terms and conditions of this Agreement are to remain unchanged.
