



BACKGROUND:

By Minute Order dated April 20, 2010 (agenda item 3.71) the Board authorized the Clerk of the Board to advertise for the construction of street improvements including lighting, sidewalk, and associated improvements on various streets in the Rubidoux area. Bids for the project were opened in the office of the Director of Transportation at 2:00 PM, Wednesday, May 19, 2010. Four responsive bids were received. The lowest responsive bid was submitted by Hillcrest Contracting, Inc. in the amount of \$1,965,082, which includes the Base bid and two alternate bid schedules for Rubidoux Community Service District (RCSD).

RCSD has approved the award of Alternate Bid Schedule 1 as bid by the apparent low bidder, and the cost for the work will be funded by RCSD. RCSD has requested the County to not award Alternate Bid Schedule 2 due to the higher than expected bids received, and has informed the County that RCSD will perform the work with their own forces.

The total of Base Bid and Alternate Bid Schedule 1 is \$1,882,482 which is \$65,711 (3.37%) less than the Engineer's Estimate. The project costs are within the project's proposed budget as shown on Attachment "A". As well, the budget is being revised to reflect the change due to elimination of Alternate bid schedule 2.

An amendment to the funding agreement is submitted separately and concurrently, with this construction contract award, for approval to the Board of Supervisors.

The Project will benefit the project area by significantly improving the existing infrastructure and pedestrian access in an area currently characterized by intermittent sidewalks, drainage problems and dirt frontages. Street lights maintenance and operation costs will be funded on an ongoing basis by Landscaping & Lighting Maintenance District No. 89-1-Consolidated (L&LMD No. 89-1-C) and RCSD.

The Rubidoux Area Street Improvements will be completed in 2 Groups. Group 1 improvements are located south of Mission Blvd, east of Riverview Dr, and north of 42nd Street/Tilton Ave, however Group 2 Improvements are located on various streets, including Pacific Avenue, Tilton Avenue, 42nd Street (East), Fort Drive, Molino Way (East), and Twining Street, and will be constructed in FY 2010/11, following the construction of Group 1 improvements.

The Group 2 improvements were separated from the Group 1 improvements due to necessary right of way acquisition, flood control improvements and the design of street lighting.

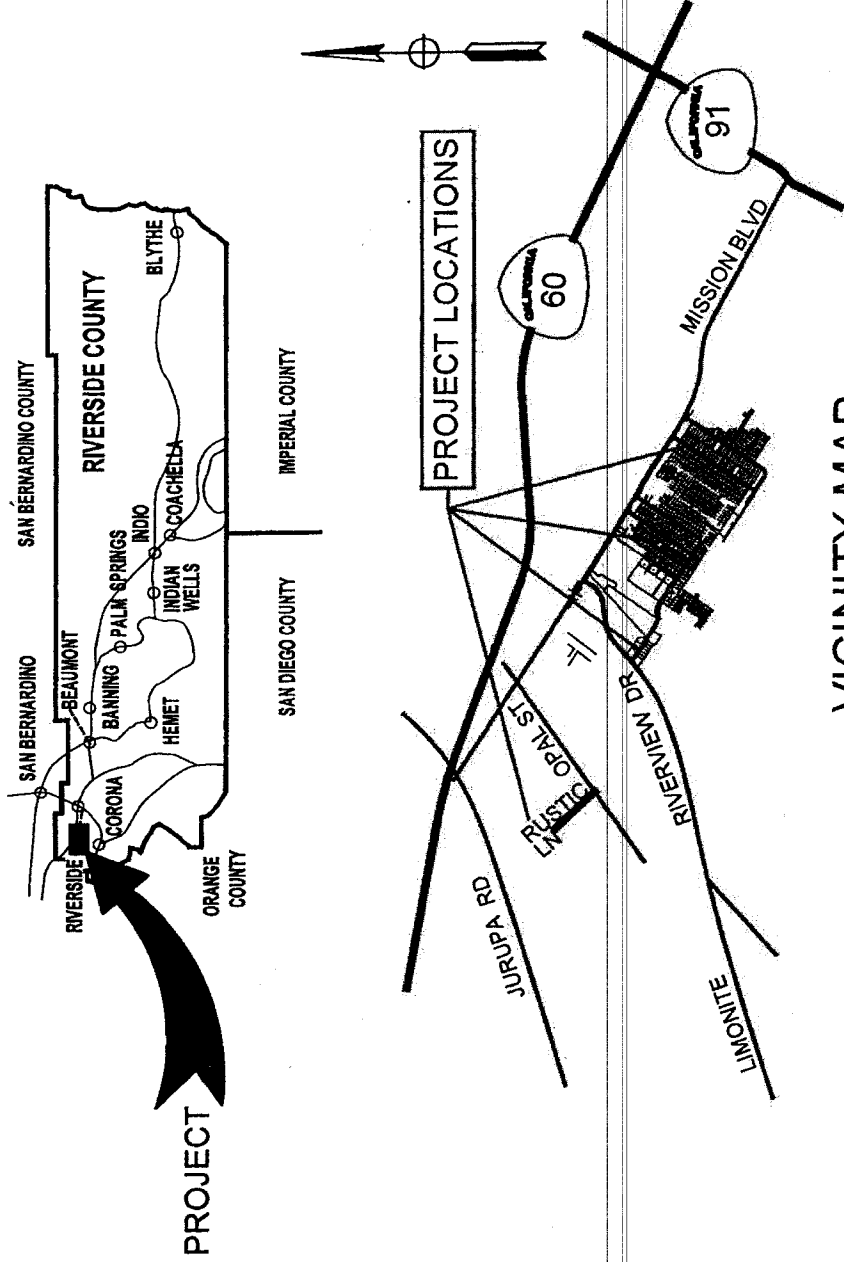
