**BACKGROUND:**

The City of Moreno Valley is widening Heacock Street Bridge which crosses the District's Perris Valley Channel, Lateral A. The area affected by these improvements was acquired by the District in 1953 to improve the existing drainage ditch and in 1995 the facility was improved to its ultimate width. The right of way described refers to APN 316-020-011, being RCFC Parcel 4010A-15, and APNs 316-020-029 and 316-020-031, which are referenced as RCFC Parcels 1040A-37A and 37B. The District has reviewed and approved the plans for the removal of a portion of the District's channel and construction of approximately 39.5 feet of bridge which will transition into the existing channel. The City of Moreno Valley has signed an agreement to own, operate and maintain these improvements, being approximately 16,257sq/ft. As this is a betterment to the District's facility and a benefit to the public, the District recommends that the right of way referenced as RCFC Parcel Numbers 4010A-27H, 4010A-27I and 4010A-27J, which are shown on Exhibits A and B, be granted to the City of Moreno Valley. All costs shall be borne by the City of Moreno Valley.

BE IT RESOLVED, DETERMINED AND ORDERED by the Board of Supervisors of the Riverside County Flood Control and Water Conservation District in regular session assembled on July 27, 2010, notice is hereby given, pursuant to California Water Code – Appendix, Chapter 48, Section 48-9, Paragraph 5, that it intends to convey the fee title interest in a portion of the District's Parcel Nos. 4010A-15, 4010A-37A and 4010A-37B by conveying at or after 1:30 p.m. on August 31, 2010 to the City of Moreno Valley, in certain real property in the city of Moreno Valley, County of Riverside, State of California, a portion of Assessor's Parcel Numbers 316-020-011, 316-020-029 and 316-020-031, being approximately 16,257 square feet, as described in Exhibit "A" and shown on Exhibit "B", attached hereto and made a part hereof.

BE IT FURTHER RESOLVED AND DETERMINED that the interest to be conveyed is for a bridge widening of Heacock Street Bridge and improvement of the existing flood control facility. The operation and maintenance of Heacock Street Bridge shall become the responsibility of the City of Moreno Valley pursuant to a Cooperative Agreement executed by both parties.

BE IT FURTHER RESOLVED that the Clerk of the Board of Supervisors is directed to give notice hereof as provided in Section 6061 of the Government Code.
