Resolution No. 2010-210, Notice of Intention to Purchase Real Property Interests, Assessor's Parcel Number 473-120-010 for the Public Safety Enterprise Communications Project

BACKGROUND:

As part of the Public Safety Enterprise Communications (PSEC) project, the County seeks to acquire property interests along Redlands Boulevard in the Timoteo Canyon area northeast of Moreno Valley (Exhibit I), identified as Assessor's Parcel Number 473-120-010, to enable access to adjacent property for the purpose of developing a proposed facility composed of a tower, shed and generator in a fenced compound.

Compensation to the owner and transaction costs for the project will be fully funded through the currently appropriated FY 2010/11 PSEC budget.

With approval of the California Environmental Quality Act (CEQA) Final Environmental Impact Report (FEIR), it is now possible to proceed with site acquisition and development for the PSEC Site. The FEIR addresses mitigation requirements and unavoidable environmental impacts stemming from the construction and operation of the proposed public safety project. This Board submittal is for a PSEC site located along Redlands Boulevard in the Timoteo Canyon area northeast of Moreno Valley. Completion of the CEQA process was approved by the Board on September 2, 2008.

This resolution has been reviewed and approved by County Counsel as to legal form. Notice per Government Code 6063 is being completed by the Agency.

FINANCIAL DATA:

The following summarizes the funding necessary to this acquisition:

All costs associated with these acquisitions are fully funded through the PSEC budget for FY 2010/11; thus, no additional net county cost will be incurred as a result of these transactions.

NOTICE OF INTENT TO PURCHASE REAL PROPERTY INTERESTS IN THE
UNINCORPORATED AREA OF TIMOTEO CANYON IN THE COUNTY OF RIVERSIDE

Notice is hereby given pursuant to Section 25350 of the California Government Code that the Board of Supervisors of the County of Riverside intends to purchase real property interests in that certain land indentified as Assessor's Parcel Number 473-120-010, and it will consider County Resolution 2010-211 and an Agreement of Purchase and Sale on August 31, 2010, or as soon thereafter as the agenda of the Board permits, at the Riverside County Administrative Center, 4080 Lemon St., 1st Floor, Riverside, California to consider the following:

PROJECT DESCRIPTIONS AND LOCATION

It is proposed that the Board of Supervisors approve Resolution 2010-211 and the Purchase and Sale Agreement by and between MV Ranchos, L.P. and the County of Riverside. The proposed agreement specifies that various real property interests consisting of approximately 2.0 acres over a portion of the land known as Assessor's Parcel Number 473-120-010, located adjacent to Redlands Boulevard in the County of Riverside, will be purchased for \$32,000.
