SUBJECT: Miles Avenue Bridge and Clinton Street Construction Project - Amendment No. 1 to the Funding Agreement between the County of Riverside (COUNTY), City of Indio (CITY) and the Coachella Valley Association of Governments (CVAG)

RECOMMENDED MOTION: That the Board approve the attached Amendment No. 1 to the Funding Agreement between the COUNTY, CITY and CVAG for the above reference project, and authorize the Chairman to execute the same.

BACKGROUND: On September 4, 2007, the Board executed a funding agreement between the COUNTY, CITY and CVAG which provided \$22,000,000 in total project funds for the Miles Avenue and Clinton Street widening project. The funding agreement includes a provision for CVAG to fund 75% of the total project costs and for CVAG to provide a loan to the COUNTY for


THIS AMENDMENT NUMBER 1 is made and entered into this 6 day of APRIL, 2011, by and between the **County of Riverside (Lead Agency)**, the **City of Indio ("Agency")** and the **Coachella Valley Association of Governments**, a California joint powers agency, ("CVAG").

This amendment approves additional work and obligates and authorizes for expenditure, funds not previously authorized under the terms of the existing Reimbursement Agreement, approved by CVAG's Executive Committee on June 4, 2007. This Amendment Number 1 authorizes additional work as shown on Exhibit A – Scope of Work. This Amendment Number 1 increases CVAG contribution to this project by an amount not to exceed \$75,000 as shown in Exhibit B – Estimate of Cost. All other provisions of the original Reimbursement Agreement remain in force.

Agreement for the Miles Avenue Bridge and Clinton Street Construction Project

County of Riverside - City of Indio - CVAG

In June, 2007, the Executive Committee approved an agreement with the City of Indio and Riverside County to fund the cost of constructing a bridge across the Whitewater River channel on Miles Avenue, and to improve Miles Avenue to Clinton Street, then north on Clinton Street to Fred Waring Drive. The Agreement provided for an estimated construction cost of \$22 Million, with costs to be shared through the typical funding arrangement of 75% CVAG Regional Funds/ 25% Local Funds. Construction on the project began in June, 2008.

As part of the pre-construction investigations, it was discovered that the location of an existing waterline, owned and maintained by the Boe-Del Heights Mutual Water Association, within the Miles Avenue portion of the work was in conflict with the proposed improvements and must be relocated. Further examination of the existing waterline indicated that given the age and condition of the pipeline, it would be more efficient to replace the waterline with new material, in a different location. The County estimates that the cost to replace and relocate the conflicting waterline, estimated at \$100,000.
