SUBJECT: Notice of Completion for the Construction of Landfill Gas Collection System at the Anza Sanitary Landfill

RECOMMENDED MOTION: That the Board of Supervisors:

1. Accept the Construction of a Landfill Gas Collection System at the Anza Sanitary Landfill by BAS Construction, LP and authorize the Chairman to execute the attached Notice of Completion; and
2. Direct the County Clerk to file the executed Notice of Completion.

BACKGROUND: On December 8, 2009, the Board awarded BAS Construction, LP the contract for Construction of a Landfill Gas Collection System at the Anza Sanitary Landfill for the total amount of \$55,962.90. On April 30, 2010, the construction of a Landfill Gas Collection System at the Anza Landfill was satisfactorily completed. The final cost for the Project was \$59,475.82, 6% greater than the original contract amount. The additional \$3,512.92 spent on the project resulted from additional quantities of vertical collection well and piping required to be installed due to actual site conditions.
