SUBJECT: Authorization to Reissue County Stale-Dated Warrants #2011 - 1

RECOMMENDED MOTION:

Authorize the re-issuance of County Stale-Dated Warrants pursuant to Government Code Section 29802.

BACKGROUND:

Governmental Code 29802 requires a warrant to become void (stale-dated) if it has not been presented for payment to the County Treasurer within six months after the issuance date. Within two-years from the date on which the original warrant becomes void, the payee or assignee of any warrant may request for the warrant to be re-issued. Pursuant to Board Resolution 82-278 (amended Board Agenda 3.5 8/6/1996), the Board of Supervisors approval is needed for amounts \$10,000 and greater. In addition, any warrant that is older than the two years requires Board approval. Attachment "A" the total amount of \$59,155 represents \$214 in stale-dated warrants over two-years old, and \$58,941 in stale-dated warrants over \$10,000.
