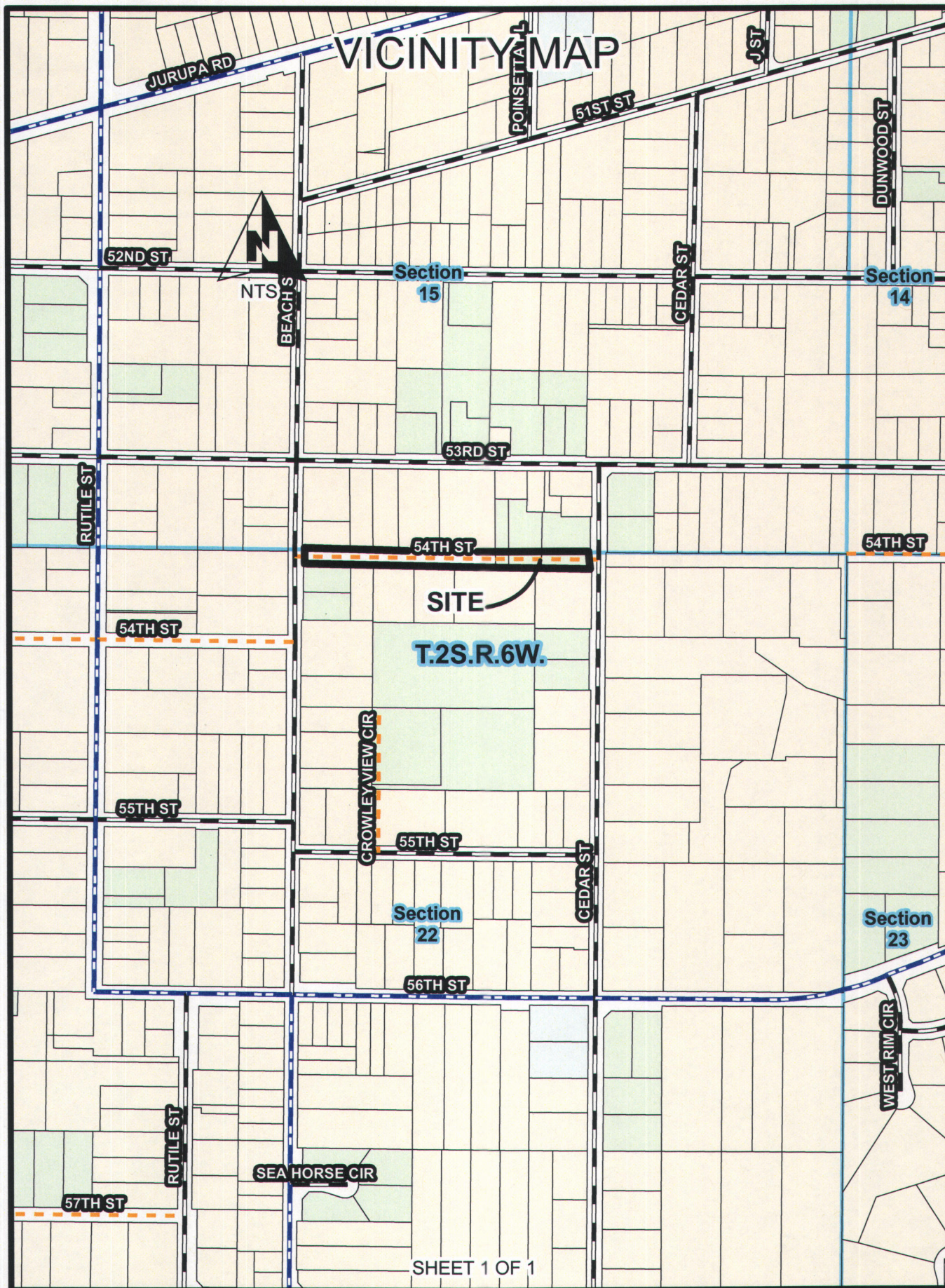

23 become part of the County Maintained Road System unless subsequently accepted into said
24 Maintained Road System by a resolution adopted by this Board;

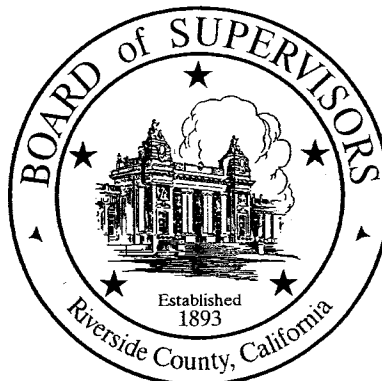
