BACKGROUND:

The Redevelopment Agency (Agency) is proposing to develop a library on a 3.24-acre property at the northeast corner of Clark Street and Oakwood Street in the unincorporated community of Mead Valley. The proposed Project involves the design and construction of a state-of-the-art full service library. The facility will consist of a 10,000 square foot library and an attached community room. The full scope of construction will include a parking lot, landscaping, community garden park, and associated off-site infrastructure improvements.

Final plans and specifications are expected to be completed in the first quarter of 2011 and staff will return to the Board of Directors to request approval of the plans and specifications at that time.

Staff recommends approval of all motions and that the Board conduct a public hearing regarding the proposed project, pursuant to Section 33679 of the California Health and Safety Code. Attached is a summary report which has been made available to the public, detailing the facts supporting the redevelopment purposes for this Project.

Agency staff recommends that the Board consent to the payments by the Redevelopment Agency for the Project, which have been estimated to be approximately \$15 Million, so the Redevelopment Agency may proceed with engineering and design of the improvements.

Summary Report: Mead Valley Library Project

(As required by Section 33679 of the Health and Safety Code: Community Redevelopment Law)

Project Description:

The Mead Valley Library Project (Project) will be located on a County owned 3.24 acre parcel at the corner of Clark Street and Oakwood Street in the Mead Valley unincorporated area of Riverside County California. The Project consists of a new approximately 20,000 square foot public library and community room including a central courtyard, parking lot, lighting, landscaping, and street improvements including sidewalk, curb and gutter, and a bus stop.

Project Site:

The Project site (Site) is located in the City of Perris on the Northern edge in the Mead Valley Sub-Area of the I-215 Corridor Redevelopment Project Area. The Site is bounded by Oakwood Street to the South and Clark Street to the West. The Site is a 3.24 acre parcel owned by the County of Riverside. The site is surrounded by residential housing and the nearby Mead Valley Fire station. Interstate 215 is the closest major North-South artery near the area with Cajalco Expressway as the major east-west artery.

Project Cost:

The total Project cost is estimated at approximately \$14 million. It is proposed that the Redevelopment Agency will provide funding for the entire project.

Findings:

The following findings have been made pursuant to Section 33445 of the Health and Safety Code:

- A. The construction of the proposed Project is of benefit to the Mead Valley Sub-Area of the Interstate 215 Corridor Redevelopment Project Area (Project Area) and will help to effectuate the purposes of the Redevelopment Plan for the Project Area:
- B. No other reasonable means of financing the Project are available to the community due to the fact that the current economic crisis has substantially reduced the community's revenues to fund the Project;
- C. The payment of funds for the cost of the Project is consistent with the Implementation Plan for the Project Area and is necessary to effectuate the purpose of the Project Area's Redevelopment Plan, which calls for construction of library facilities.

Purpose:

The proposed Project meets the following goals of the Mead Valley Sub-Area of the Interstate 215 Redevelopment Project Area:

- A. The Site, which is currently undeveloped, will be improved by providing a new public Library with new facilities including a community room that will provide an opportunity for youth and adult educational needs, recreational activities, community events, and social gatherings;
- B. The development of the Site will enhance the physical appearance and the effective use of the vacant property in the Project Area by constructing a new beautifully landscaped Library and community room;
- C. The development of the Site will promote learning through reading and provide a means of using technology to learn and have the ability to gain access to public information;
- D. Provide a means of improvement and centralization of recreational activities and community events that will be accessible to the community.
