**CONSENT TO ASSIGNMENT
of
AGREEMENT FOR STREET SWEEPING SERVICES**

This **Consent to Assignment** is entered into as of the Effective Date set forth below by COUNTY OF RIVERSIDE, a political subdivision of the State of California (hereinafter referred to as the "COUNTY"), and concerning Interstate Sweeping Services hereinafter referred to as "CONTRACTOR").

RECITALS

A. On August 1, 2006, the COUNTY and CONTRACTOR entered into an agreement for Street Sweeping Services, for services regarding service on various county streets, hereinafter referred to as "Agreement").

B. Section 4. of the Agreement states that the services may not be assigned without the prior written consent of COUNTY.

C. CONTRACTOR now desires to obtain COUNTY's consent to the acquisition of CONTRACTOR by CR&R Incorporated.

NOW, THEREFORE, in consideration of the foregoing, COUNTY agrees as follows.

OPERATIVE PROVISIONS

1. CONSENT.

COUNTY consents to the assignment by CONTRACTOR of Agreement, as represented by its acquisition into CR&R Incorporated.

2. TERMS.

All terms of the Agreement, inclusive of obligations and liabilities, shall be and remain fully applicable to CONTRACTOR and the services to be performed thereunder as when first executed. All references in said Agreement to CONTRACTOR shall hereafter be understood to refer to CR&R Incorporated.
