Bob Schiffner enlisted with the Merchant Marines as a "ships carpenter" during World War II and began his civil service while working for the city of Long Beach for 28 years as a draftsman and inspector. After moving to Lake Elsinore in 1992, he "fell in love with the city" and was "passionate about the infrastructure and growth" and providing a "better place for families." He was involved in numerous community development projects, supported the addition of several fire stations in the city, and was devoted to cleaning up and preserving the "lake."

Bob Schiffner, a loving family man who was "dedicated to his community" with a "lifetime of public service," will be greatly missed by those who knew and loved him.

Dick Kelly served in the Army Air Corps Utility Company during World War II. After retiring from a lengthy career with General Telephone and Electronics/Verizon, he was elected to the Palm Desert City Council in 1982, where he served his community for over 28 years and was elected as mayor six times.

Dick Kelly was a "true role model" and "compassionate" man who made a "strong impact" on the community and went out of his way to make sure the residents were cared for. He was a "leader" on transportation issues in the valley, including Palm Desert's initiative to make golf carts street legal, and was the "driving force" behind development of the Desert Willow Golf Resort in Palm Desert. He also helped the Sunline bus line in getting access to the freeway.

Dick Kelly was a devoted family man whose "humor, faith, and giving nature" will live forever in the hearts of those who knew and loved him.
