

**HOT MINERAL WATER RESOLUTION
OF THE DESERT EDGE COMMUNITY COUNCIL**

Adopted January 9, 2007

**To: Honorable Roy Wilson
Supervisor, 4th District
County of Riverside**

Whereas the Desert Edge community is fortunate to have access to some of the finest therapeutic natural hot mineral water in the world;

Whereas this water is considered a real treasure and must be conserved and protected from overuse, infiltration of chemicals, and human waste;

Whereas the Desert Edge Community Council (formerly known as the "Hot Springs" Community Council) was established by Resolution No. 2005-447 of the Riverside County Board of Supervisors *"for the purpose of advising the Board of Supervisors on matters including, but not limited to, public health, safety, welfare, public works, and planning"*;

Whereas the Board of Supervisors recognized the importance of hot mineral water to the community when they designated the Hot Springs Policy Area *"to encourage the development of destination resorts, health and fitness facilities and special needs housing that is specifically designed for utilization of the hot mineral water thermal resources . . ."* (Western Coachella Valley Area Plan (WCVAP 3.1), p. 26);

Whereas there exists at this time no County codes that implement requirements for managing therapeutic hot mineral water resources for conservation of supply, adequacy of temperature, and bacterial or industrial contamination;

Whereas that to manage any resource requires certain measurements over periods of time in order to provide quantifiable data for use in making long-term resource management decisions;

Whereas the knowledgeable interpretation of such data requires the technical expertise of trained and experienced practitioners in geothermal hydrogeology;

Whereas new development projects that require installation of new wells for hot mineral water are being proposed at an ever increasing rate in the Hot Springs Policy Area;

Be it therefore resolved that we hereby petition the Board of Supervisors to establish the following requirements for new hot water wells, and to include them in the 2007 Design Guidelines for the Hot Springs Policy Area.:

- (a) Other than for existing households dependent on wells, the use of hot mineral water (85 degrees Fahrenheit or greater) for other than human therapeutic purposes or agricultural use is expressly prohibited. The waste water from hot mineral water wells

shall be used for other agrarian purposes, and not returned through the sewage system. A flow-through system from hot water wells into community pools and spas to an aeration pond that recharges the ground water through clean recycling is encouraged.

(b) Before any well drilling permit is granted in the Hot Springs Policy Area the application must include a statement by a qualified engineer or geothermal hydrology specialist stating the expected maximum flow rate, the maximum integrated flow per month, the expected normal integrated flow per year, and the method(s) employed to control wastage of water and heat. The application shall include an engineering flow diagram showing piping and depth, flow and temperature instrumentation from well to final discharge, and a scale map showing locations of other wells within 1000 feet.

(c) All development applications for a Conditional Use Permit submitted for technical review to the Riverside County Planning Department, and subsequently to the Desert Edge Community Council, shall include either a statement that no hot mineral water will be used or follow guidelines for acquiring a well drilling permit, as set forth in item (b) above.

(d) The piping of hot mineral water to individual housing units in a multiple unit development is prohibited. All use of hot mineral water must be in common facilities, such as a community or clubhouse pool and spa.

(e) All new wells must be equipped with application-suitable industrial quality instrumentation to measure and record integrated flow rate, temperature and well water level under both pump-on and pump-off operation.

(f) That the County engage by contract a qualified hydro-geologist experienced in geothermal aquifers to advise the County concerning details of the instrumentation, record-keeping program and review of data, including recommendations for further management of the hot mineral water resource.

(g) That the County Department of Environmental Health be required to establish and carry out a program of bi-monthly sampling and analysis of all hot water wells for bacterial and industrial contamination.

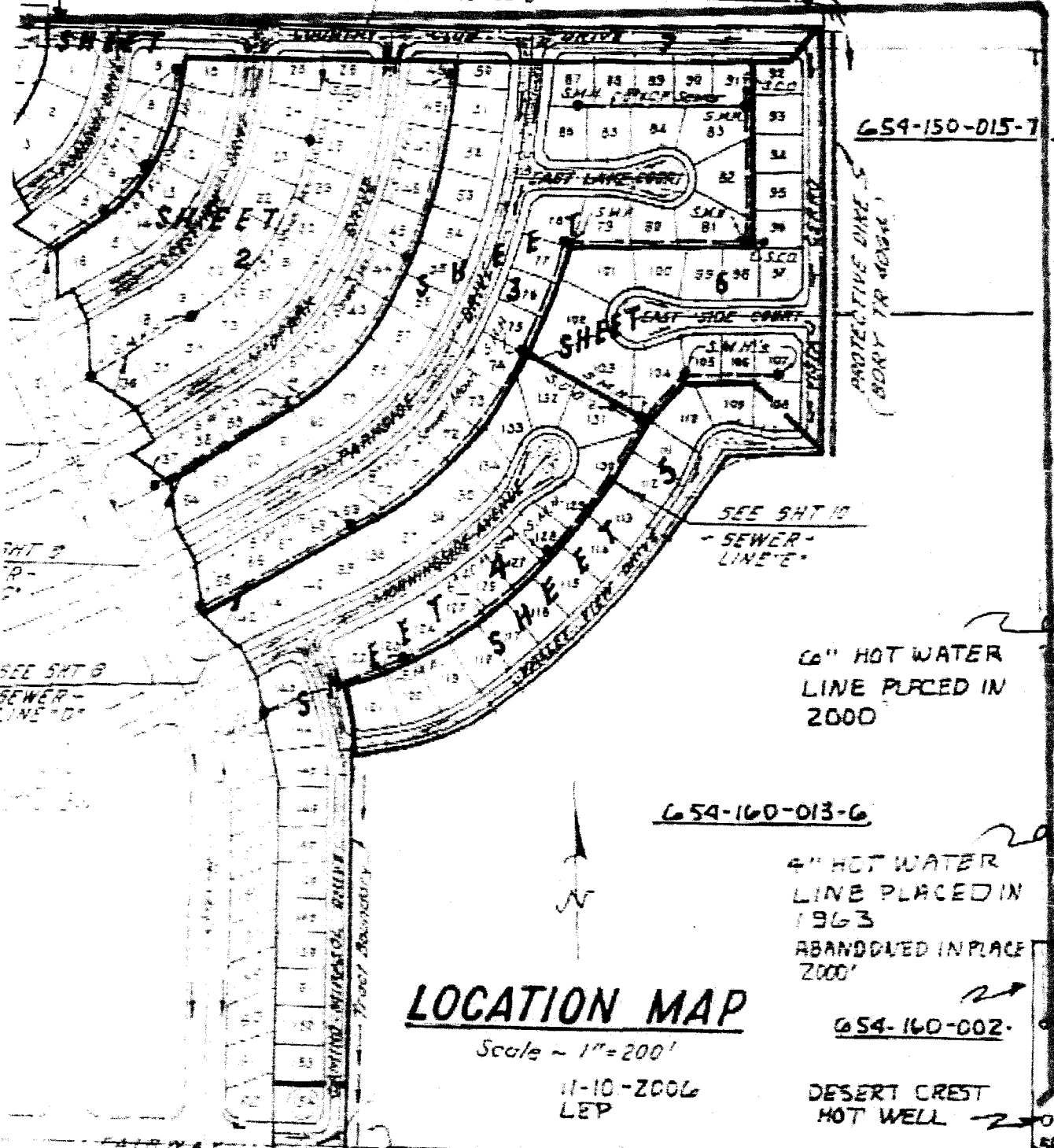

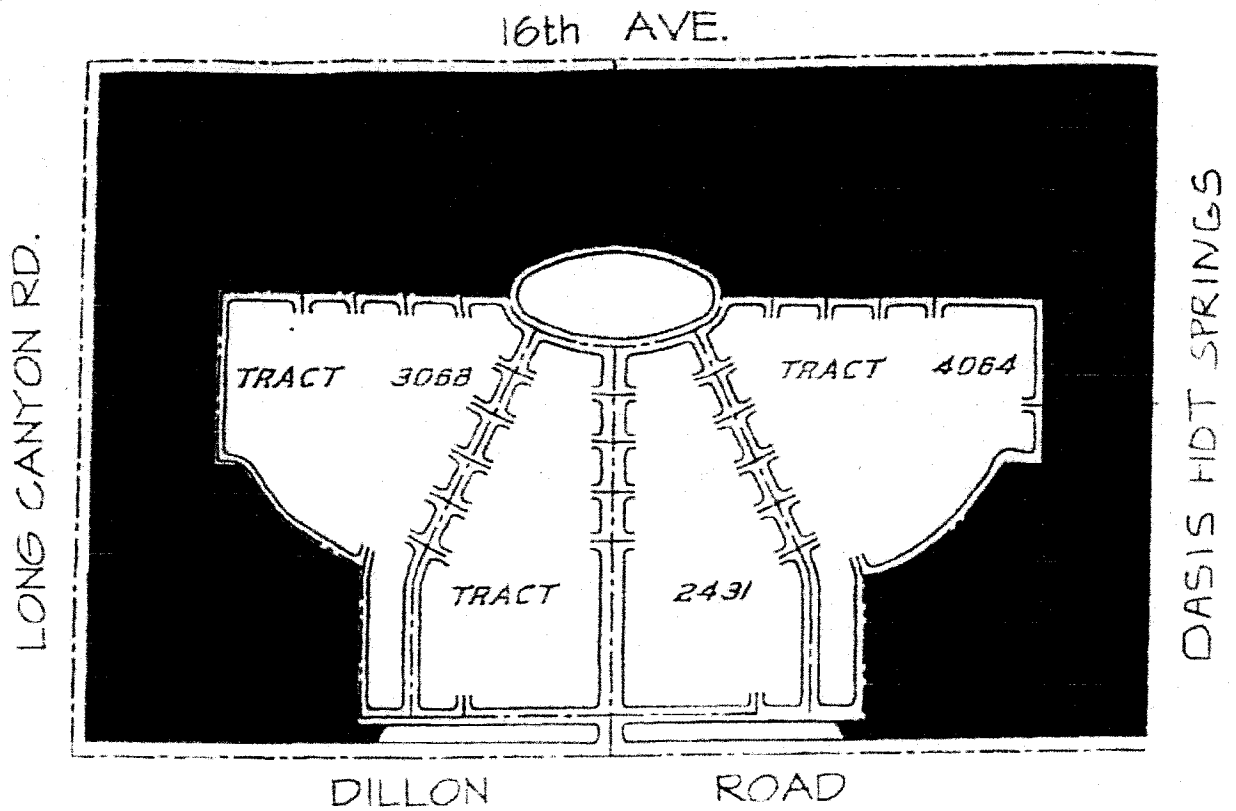
