

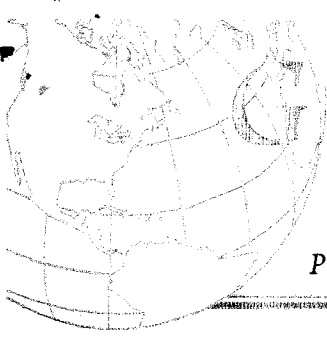
**BACKGROUND:** (Continued)

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, the Tax Collector conducted the March 12, 2007 public auction sale. The deed conveying title to the purchasers at the auction was recorded May 3, 2007. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on June 4, 2007, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were used to obtain current mailing addresses for these parties of interest.

The Treasurer-Tax Collector has received three claims for excess proceeds:

- 1) Claim from Global Discoveries, Ltd., assignee for Matias Pulido Godoy based on an Assignment of Right to Collect Excess Proceeds dated May 31, 2007, a Quitclaim Deed recorded January 12, 1999 as Instrument No. 011918 and an Affidavit-Death of Joint Tenant recorded June 2, 1999 as Instrument No. 241539.
- 2) Claim from Riverside County, Department of Child Support Services based on an Abstract of Support Judgment recorded July 26, 2000 as Instrument No. 2000-286925.
- 3) Claim from Global Discoveries, Ltd., assignee for Salvador Pulido Godoy based on an Assignment of Right to Collect Excess Proceeds dated May 31, 2007, a Quitclaim Deed recorded January 12, 1999 as Instrument No. 011918 and an Affidavit-Death of Joint Tenant recorded June 2, 1999 as Instrument No. 241539.

Pursuant to Section 4675 (a) & (b) & (e) of the California Revenue and Taxation Code, it is the recommendation of this office that Global Discoveries, Ltd., assignee for Matias Pulido Godoy be awarded excess proceeds in the amount of \$31,242.99, Riverside County, Department of Child Support Services be awarded excess proceeds in the amount of \$31,139.98 and Global Discoveries, Ltd., assignee for Salvador Pulido Godoy be awarded excess proceeds in the amount of \$103.01. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.
