Among his many accomplishments, Tom created one of the only vegetable garden and animal sanctuaries known as the "Farm" which served as an "educational hub" that taught "pride and ownership" to students, parents, and teachers.

Eugene Yeager was one of three sons to Ernest Louis Yeager, founder of E.L. Yeager Construction Company in Riverside in 1919. Subsequent to enlisting in the Navy in 1943 and being appointed to the U.S. Naval Academy, he returned to UC Berkely at the end of World War II and completed his degree in civil engineering in 1948. Eugene and his brothers Jacques and Richard took over the family business for their father in 1952, creating one of the largest public works and private construction companies in the country, and were instrumental in building freeways, bridges, and dams across Southern California, including the Highway 91/Interstate 15 interchange in Corona, the freeway through Cajon Pass, the Lake Perris Dam, and the Auto Club Speedway.

Eugene Yeager, a devoted and loving family man, will always be remembered as a "philanthropist" who was "very humble" and "gave from the heart." He will be greatly missed by the community and by everyone who knew and loved him.
