This Project involves installing new communication infrastructure in Downtown Riverside for the Riverside County Information Technology (RCIT) Department. A new communications vault and concrete encased conduits will be installed in Orange Street south of and within the intersection with 10th Street. All installation and termination of wires will be the responsibility of RCIT.
