#### **BACKGROUND:**

On June 1, 2010, RDA published a Request for Qualification (RFQ) From General Contractors for the Home Rehabilitation and Senior Home Repair programs to perform various rehabilitation services for both the East and West County.

The Board of Directors approved the list of contractors and the Contractor Participation Agreement template on August 10, 2010.

On August 16, 2010, RDA published a Request for Qualification (RFQ) From General Contractors for the HRP and SHR programs for the East County in order to expand the number of contractors on the approved list for the East County. The deadline for the RFQ was September 8, 2010. The East County is defined as all unincorporated areas of Riverside County, east of the City of Banning to the Colorado River and the following cooperating cities; Banning, Blythe, Cathedral City, Desert Hot Springs, Indian Wells, and La Quinta. The RFQ was prepared for the purpose of developing a limited number of licensed general contractors to perform various rehabilitation services on an, "as-needed basis" for the eastern portion of Riverside County.

Pre-qualifying a pool of contractors will enable RDA to quickly respond to the needs of the residents and will accelerate the delivery of services. RDA will assess the home and prepare a scope of work and solicit bids from the selected Pre-qualified Contractors List. A competitive bidding process will be followed in accordance with the procurement policy.

A total of ten (10) contractors responded to the RFQ, and based on the submittals, RDA has qualified sevens (7) contractors as the most responsive and qualified contractors as shown in the Attachment "A". The qualified contractors will be required to enter into a Contractor Participation Agreement prior to the issuance of any work order. The Pre-qualified Contractors List will be valid for one year following the date of approval per Public Contract Code Section 20100(c).

Staff recommends that the Board of Directors approve the attached Pre-qualified Contractors List. County Counsel has reviewed and approved as to form the attached Pre-qualified Contractors List.
