To alleviate confusion and address safety concerns, the Riverside County Transportation Department is proposing to change the name of this portion of Tenaja Road to Cleveland Forest Road.

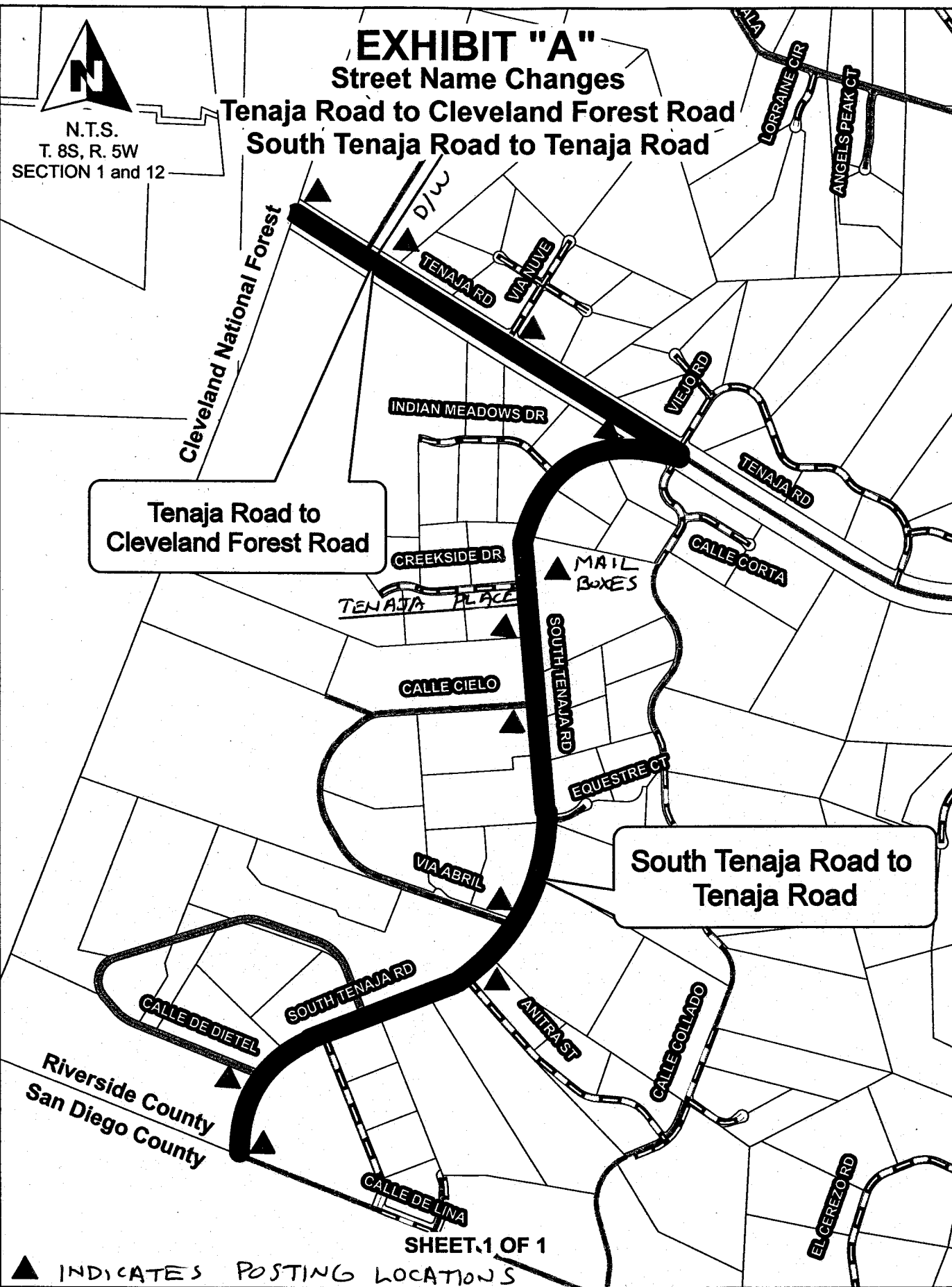
