On motion of Supervisor Benoit, seconded by Supervisor Ashley, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, September 28, 2010, is adjourned in memory of Victor Miceli, 82 years old, resident of Riverside, an "extraordinary" man and retired Riverside County Superior Court Judge who touched many lives in the legal community and whose "profound positive impact" on the City and County of Riverside and beyond will continue to be felt for generations.

Victor Miceli was a private civil practice attorney who came to Riverside in 1961 from Pennsylvania and was appointed to the Superior Court bench in 1986 by Governor George Deukmejian. Serving as presiding judge during his tenure, he ruled on many high-profile cases involving local politics, growth, and environmental issues.

Victor Miceli led the efforts to establish a downtown Riverside Justice Center and restore and preserve the City's Historic Evergreen Cemetery. His "personal project" he was "most proud of" was restoring the 1903 Historic Courthouse to its "original splendor," and he was often up at dawn to inspect the day's work on the courthouse, wearing a hard-hat and going over the smallest details.

Victor Miceli, a "fun and optimistic person" with a great sense of humor, was a devoted husband and father and friend and mentor to all who had the pleasure of working with him. His memory shall live on in the hearts and minds of everyone who knew and loved him!
