



#### **SUMMARY OF EVIDENCE**

- 1. Documents of record in the Riverside County Recorder's Office identify the owners of THE PROPERTY as Donnie O. Turner, Josephine Hayes and Irene Jackson ("OWNERS").
- 2. Documents of title indicate that other parties potentially hold a legal interest in THE PROPERTY, to wit: Franchise Tax Board of the State of California, Enice W. Singletary and Geraldine Singletary ("INTERESTED PARTIES").
- 3. THE PROPERTY was inspected by Code Enforcement Officers on August 15, 2006, April 19, 2007, October 4, 2007, November 6, 2007, March 6, 2008, April 22, 2008 and May 16, 2008.
- 4. During each inspection, a substandard structure (dwelling) was observed on THE PROPERTY. The structure was observed to be abandoned, dilapidated and vacant. The structure contained numerous deficiencies, including but not limited to: extensive fire damage; lack of improper water closet, lavatory, bathtub, shower or kitchen sink; deteriorated or inadequate foundation; defective or deteriorated flooring or floor supports; dampness of habitable rooms; faulty weather protection; fire hazard; attractive and public nuisance.
- 5. During each inspection an accumulation of rubbish was observed throughout THE PROPERTY consisting of but not limited to: books, magazines, wood, household trash and household furniture, and other miscellaneous trash and debris. All items of rubbish had weather damage and/or fire damage.
- 6. THE PROPERTY was determined to be in violation of Riverside County Ordinance No. 457 (RCC Title 15) and 541 (RCC Chapter 8.120) by the Code Enforcement Officer.
- 7. A Notice of Noncompliance for the substandard structure and accumulation of rubbish was recorded on September 5, 2007, as Document Number 2007-0566945 in the Office of the County Recorder, County of Riverside.
- 8. On April 19, 2007, a Notice of Violation, Notice of Defects and a "Danger Do Not Enter" signs were posted on THE PROPERTY. On May 10, 2007, a Notice of Violation and Notice of Defects were mailed by certified mail, return receipt requested to OWNERS. On September 20, 2007, a Notice of Defects and Notice of Violation were mailed to OWNERS and INTERESTED

PARTIES by certified mail, return receipt requested.

9. On April 18, 2008, a "Notice to Correct County Ordinance Violations and Abate Public Nuisance" providing notice of the public hearing before the Board of Supervisors on May 20, 2008 was mailed by certified mail, return receipt requested, to OWNERS and INTERESTED PARTIES and was posted on THE PROPERTY on April 22, 2008.

#### **FINDINGS AND CONCLUSIONS**

WHEREFORE, the Board of Supervisors of the County of Riverside, State of California, in regular session assembled on May 20, 2008 finds and concludes that:

- 1. WHEREAS, the substandard structure (dwelling) and accumulation of rubbish on the real property located at 20940 Oleander Avenue, Perris, Riverside County, California, also identified as Assessor's Parcel Number 295-150-007 violates Riverside County Ordinance Nos. 457 (RCC Title 15) and 541 (RCC Chapter 8.120) and constitutes a public nuisance.
- 2. WHEREAS, THE OWNERS, occupants and any person having possession or control of THE PROPERTY should abate the substandard structure (dwelling) by razing, removing and disposing of the substandard structure, including the removal and disposal of all structural debris, materials, and contents therein or by reconstruction and rehabilitation of said structure provided that said reconstruction or demolition can be accomplished in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance No. 457 within ninety (90) days.
- 3. WHEREAS, THE OWNERS, occupants and any other person having possession or control of THE PROPERTY should abate the accumulation of rubbish by removing and disposing of all rubbish on THE PROPERTY in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance No. 541 within ninety (90) days.
- 4. WHEREAS, THE OWNERS AND INTERESTED PARTIES ARE HEREBY FURTHER NOTICED that the time within which judicial review of the administrative determinations made herein must be sought is ninety (90) days from the posting and mailing of the Findings of Fact, Conclusions and Order To Abate Nuisance, and is governed by California Code of Civil Procedure Section 1094.6.

ORDER TO ABATE NUISANCE

IT IS THEREFORE ORDERED that the substandard structure (dwelling) on THE PROPERTY be abated by the OWNERS, specifically Donnie O. Turner, Josepine Hayes and Irene Jackson or anyone having possession or control of THE PROPERTY, by razing and removing the substandard structure (dwelling) including the removal and disposal of all structural debris and materials, as well as the contents therein, or by reconstruction and rehabilitation of said structure provided such reconstruction and rehabilitation can be accomplished in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance No. 457 within ninety (90) days of the posting and mailing of this Order to Abate Nuisance.

IT IS FURTHER ORDERED that if the substandard structure (dwelling) is not razed, removed and disposed of, or reconstructed and rehabilitated in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance No. 457, within ninety (90) days of the posting and mailing of this Order to Abate Nuisance, the substandard structure, contents therein, and structural debris and materials, shall be abated and disposed of by representatives of the Riverside County Code Enforcement Department, a contractor, or the Sheriff's Department upon receipt of the owner's consent or a Court Order, where necessary, under applicable law authorizing entry onto THE PROPERTY.

FURTHERMORE, THE OWNERS are ordered to ascertain the existence or non-existence of asbestos containing materials in said structure by survey and materials sample testing by a duly licensed and certified asbestos consultant; and, prior to the abatement ordered hereinabove, to secure the removal of all asbestos containing materials discovered through such survey and testing by contract with a duly certified and licensed contractor for the handling of such materials to avoid citations and/or fines by South Coast Air Quality Management District (SCAQMD).


