BACKGROUND: Government Code § 25845, Riverside County Ordinance Nos. 457 (RCC Title 15); 541 (RCC 8.120) and 725 (RCC Chapter 1.16) and Section 1618, Article 10, Title 25 of the California Code of Regulations, provide authority for the recovery of abatement costs in public nuisance cases, the recordation of a notice of abatement lien and inclusion of abatement costs on the tax roll as a special assessment upon approval of the Board of Supervisors.

The Board of Supervisors issued an Order to Abate on April 7, 2009 with regard to Case Nos. CV 07-9865 & CV 07-9867. Subsequently, on or about Jan. 19, 2010, the substandard structures and accumulated rubbish was abated under the direction of the Riverside County Code Enforcement Department pursuant to a seizure warrant. Additionally, with regard to Case No. CV 07-9866, Ten-Day Notices of Intention to Abate Substandard Mobile Home were issued on July 14, 2008 and Aug. 14, 2009. Also, Five-Day Notices of Intention to Seize Substandard Mobile Home were issued on Sept. 5, 2008 and Sept. 24, 2009. Subsequently, on or about Mar. 29, 2010, the substandard mobile home was abated from the subject property under the direction of the Riverside County Code Enforcement Department pursuant to a seizure warrant.





The structures contained numerous deficiencies, including but not limited to: lack of improper water closet, lavatory, bathtub, shower or kitchen sink; lack of hot and cold running water to plumbing fixtures; hazardous plumbing; lack of required electrical lighting; hazardous wiring; lack of adequate heating facilities; members of walls, partitions, or other vertical supports that split; lean, list or buckle due to defective material or deterioration; members of ceiling, roofs, ceiling and roof supports or other horizontal members which sag, split or buckle due to defective material or deterioration; dampness of habitable rooms; faulty weather protection; general dilapidation or improper maintenance; fire hazard; public and attractive nuisance.
- 5. During each inspection an accumulation of rubbish was observed throughout THE PROPERTY consisting of but not limited to: discarded furniture, tiles, trash cans, bottles, cans, hoses, a wrecked camper shell, a wrecked boat, tires, scrap wood, scrap metal, rubble, metal barrels, plastic, scrap carpet, old water heaters, cardboard, trash, green waste, discarded clothes and garage doors.

WHEREAS, THE OWNER, occupants and any other person having possession or control of THE PROPERTY should abate the accumulation of rubbish by removing and disposing of all rubbish on THE PROPERTY in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance No. 541 within ninety (90) days.






